

- 11. A separate report should be sent in respect of each constituency.
- 12. The report should cover all contesting candidates, whether they have been elected or defeated at the poll.
- 13. The name of the constituency shall be spelt exactly in the same manner as in the Delimitation Order. The names of the candidates shall be spelt as in the list of contesting candidates.
- 14. In determining the last date by which the accounts of election expenses are to be lodged by the contesting candidates, the date on which the returned candidate has been declared elected shall not be taken in to account while calculating the period of 30 days under section 78 of Representation of the People Act, 1951.
- 15. Amount Lodged by Candidates after the last date should be examined and material defects, if any, should be recorded in column 7.
