Whereas, the COVID-19 has been declared as pandemic by the World Health Organization and National Disaster Management Authority, being satisfied that the district is threatened with COVID-19 pandemic.

Whereas, considering the emergent nature of current COVID-19 crisis in which district Gurugram has seen an exponential increase in the number of COVID cases especially the doubling of such cases in the last few days, the district administration is of a considered opinion that clear distinction cannot be made between crowded and lesser crowded places.

Whereas, in compliance of Government of Haryana State Disaster Management Authority order no. DMC-SPO-2020/4863 dated 23.04.2021 and in exercise of the powers under relevant provisions of the National Disaster Management Act, 2005, I, **Yash Garg, IAS, Deputy Commissioner-cum-Chairperson, District Disaster Management Authority, Gurugram** do hereby order that all the shops in district Gurugram including shopping malls/ plazas/ arcades/ community markets and other similar places (excluding essential categories like Drugs/ Pharmaceuticals/ Groceries/ Restaurants & eating places only for home delivery) will be closed by 06:00 PM everyday, with immediate effect till further orders.

Strict enforcement of the orders.

The compliance of this order shall be strictly enforced and ensured by all Executive Magistrate/ Police Officials on duty and local bodies in their respective jurisdiction. Any violation of the same shall be strictly dealt with as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general.

It shall be published for the information of public in general through the press and publicity Van of public relations department and by affixing copies at notice board of all police stations, MC's, Zila Parishad, Panchayat Samiti, Tehsil, Sub Division, District Courts and other prominent places.
