DECLARATION

WHEREAS, it was Notified by Government in the Revenue Department vide Notification NO. F. 09 (03)-REV/ACQ/II/16 dated 21-02-2018, that the land/ lands described in the schedule hereto (hereafter referred to as the said land / lands) was / were needed or likely to be needed for the public purpose, namely for the purpose of construction of approach road of R. C. C. Bridge over Halaicherra on the road connecting from Kailashahar Golakpur road & N. E. C. road via Chaidrone under Kailashahar Sub-Division in Unakoti District;

AND WHEREAS, the Government of Tripura is satisfied, on the basis of the observation made by Administrator of the concerned District that the Rehabilitation and Resettlement Scheme shall not apply under the provision of Sub-Section 2 of Section 17 of the "Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" (hereinafter referred to as "the Land Acquisition & Rehabilitation Act"), because no displacement of family / families will occur due to proposed acquisition process;

AND WHEREAS, the Requiring Body has deposited the cost of land to be acquired with the Collector;

NOW, THEREFORE, it is hereby Declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said land / lands is / are required for the public purpose, namely for the purpose of construction of approach road of R. C. C. Bridge over Halaicherra on the road connecting from Kailashahar Golakpur road & N. E. C. road via Chaidrone under Kailashahar Sub-Division in Unakoti District.

The Government is also pleased to direct the Collector, Unakoti District under Section 20 of the said Act to proceed with the works.

The Land Statement and Plan may be inspected in the Office of the Collector, Unakoti District during office hours.


