

3. Quotationer will have to deposit Rs.3000/- (Rupees Three thousand) only in favour of the District Magistrate & Collector , Unakoti District in the shape of D-Call money of any recognized Bank which will be retained in this office as security deposit in case of Successful quotationer.
4. The Quotations will be received up to 3.00 PM on 30th January 2021 and will be opened same day, if possible in presence of the tenderers of their authorized representatives.
5. On acceptance of a quotation, the quotationer shall deposit the full amount of the total quoted price on one installment within 7(seven) days from the date of intimation regarding acceptance of his/her quotation and submission of Demand Notice thereof. No claims / request for part payment shall be accepted under any circumstance. In addition the successful bidder / quotationer shall also be liable to deposit the GST as applicable on the deal to the GST authorities. Failure on the part of the quotationer to comply with the above will render his/her earnest money liable to forfeiture. No interest will be allowed on earnest money deposit. Earnest money deposit will be refunded to the unsuccessful quotationer on application as soon as the quotation is finalized except 2nd and 3rd highest bidders which shall be retained till such time delivery of the auctioned materials are completed.
