ORDER:

In compliance with the directions of the Department of Home Affairs & Justice, Government of Punjab issued vide No. SS/ACSG/2020/361 dated 06.05.2020, and further to the order of the undersigned issued vide Endst. No. 2413-2476/MA dated 04.05.2020, I, Deepti Uppal, IAS, District Magistrate, Kapurthala, exercising the powers vested in me under the Section 144 of the Criminal Procedure Code (Cr. PC), hereby, direct, that the shops along with liquor vends in District Kapurthala will remain open from 7:00AM to 3:00PM from Thursday, May 07, 2020 onwards and home delivery of liquor will be done by the licensed liquor vends from 7:00AM to 6:00PM till further orders.

Furthermore, the Food & Beverage Outlets (FBOs) including restaurants, *dhabas*, etc. are allowed to do Home Delivery Only from 7:00AM to 6:00PM daily, and sit-in dining or takeaway will not be allowed. The FBO operators will ensure that shutters of their outlets will remain closed for customers and will ensure that their kitchens are properly clean and thoroughly sanitized and workers maintain proper hygiene and take all necessary measures as mandated by the Government of India, Government of Punjab and District Administration to prevent and control the outbreak of COVID-19. For doing Home Delivery, the FBOs will have to seek permission from the Asst. Commissioner (Food Safety), Kapurthala, who will grant permission only after thorough inspection of the FBO outlets including kitchens and carry out routine inspections from time to time so as to ensure that the government norms are fully complied with.

The rest of the directions remain the same as stipulated in the order dated 04.05.2020.
