ORDER:

This is in furtherance of the Orders of the undersigned, which were issued vide this office Endst. No. 1605-1661/MA dated 20.03.2021; Endst. No. 1884-1939/MA dated 31.03.2021; Endst. No. 1248-1301/Reader to ADC/MA dated 31.03.2021; Endst. No. 2031-2084/MA dated 08.04.2021; Endst. No. 2198-2251/MA dated 17.04.2021 and Endst. No. 2424-2477/MA dated 19.04.2021.

Considering the present COVID-19 situation in the State of Punjab, the Department of Home Affairs & Justice (Home-4 Branch), Government of Punjab vide its letter bearing Memo No. 7/56/2020/2H4/2069 dated 27th April, 2021, has issued additional restrictions to be strictly & meticulously enforced throughout the State of Punjab w.e.f. 27th April, 2021 till further orders.

Therefore, in pursuance of the above-said directions of the Government of Punjab issued vide its above-mentioned letter dated 27.04.2021, and taking into account the prevailing COVID-19 situation in District Kapurthala, I, Deepti Uppal, IAS, District Magistrate, Kapurthala, by virtue of the powers vested in me under Section 144 of the Code of Criminal Procedure (Cr. PC), 1973; Section 30 of the Disaster Management Act, 2005, and Section 2 of the Epidemic Diseases Act, 1897, hereby, order the following additional restrictions for strict and meticulous enforcement within the territorial jurisdiction of District Kapurthala with effect from 27th April, 2021 till further orders:

- (i). All Shops including those in Malls and Multiplexes, etc. to close everyday by 5:00PM (with Home Delivery allowed up to 9:00PM);
- (ii). Daily Night Curfew, which is already in force from 8PM to 5AM, shall NOW be FROM 6:00PM TO 5:00AM on all days, prohibiting all the non-essential activities;
- (iii). Weekend Curfew from 5:00AM on Saturday up to 5:00AM on Monday. However, all the essential activities shall remain exempted;
- (iv). All Private Offices including Service Industry allowed to "Work from Home" only;

In addition to the above, the following activities shall subject, however, to observance of COVID appropriate behaviour by all concerned, be exempted from COVID-19 restrictions mentioned from para nos. (i) to (iv) above:

- (i). Chemist Shops and Shops dealing with supply of essential goods like Milk, Dairy Products, Vegetables, Fruits, etc;
- (ii). Manufacturing Industry: Movement of employees / labour of Manufacturing Industry and Vehicles carrying them is allowed. However, concerned industry shall issue requisite permission for this purpose;
- (iii). 'To and Fro' movement of passengers travelling via Air, Trains, Buses, etc.
- (iv). Construction activities in both the Urban and Rural Areas;
- (v). Agricultural activities including Procurement, Horticultural, Animal Husbandry, Veterinary Services;
- (vi). E-commerce and movement of all goods;
- (vii). Vaccination Out-Reach Camps

All the extant directives of the Ministry of Home Affairs (MHA), Government of India; Government of Punjab & District Administration, Kapurthala on COVID-appropriate behaviour including Social Distancing norm of maintaining minimum six (06) feet distance (*Do Gaz Ki Doori*), regulating crowds in marketplaces and public transport, and imposition of penalties prescribed for violation of COVID-appropriate behaviour like wearing of face masks and spitting in public places, etc. shall be strictly enforced.

This Order shall be applicable with effect from 27th April, 2021 till further orders.

Any violation of this Order shall be punishable under Sections 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the Indian Penal Code (IPC), 1860.
