ORDER:

This is in furtherance of the Orders of the undersigned, which were issued vide this office Endst. No. 1605-1661/MA dated 20.03.2021; Endst. No. 1884-1939/MA dated 31.03.2021; Endst. No. 1248-1301/Reader to ADC/MA dated 31.03.2021; Endst. No. 2031-2084/MA dated 08.04.2021; Endst. No. 2198-2251/MA dated 17.04.2021 and Endst. No. 2424-2477/MA dated 19.04.2021, Endst. No. 2490-2504/ MA dated 20.04.2021 and Endst. No. 2610-2663/MA dated 27.04.2021.

Considering the present COVID-19 situation in the State of Punjab, the Dept. of Home Affairs & Justice (Home-4 Branch), Govt. of Punjab vide its letter bearing Memo No. 7/56/2020/2H4/2069 dated 27th April, 2021, had issued additional restrictions to be strictly & meticulously enforced throughout the State w.e.f. 27th April, 2021 till further orders, in pursuance of which, this office had issued Order vide Endst. No. 2610-2663/MA dated 27.04.2021.

In continuation of the above-said directions issued vide Memo No. 7/56/2020/2H4/2069 dated 27th April, 2021, the Department of Home Affairs & Justice (Home-4 Branch), Govt. of Punjab has, vide Memo No. 7/56/2020/2H4/2090 dated 27th April, 2021, issued clarification pertaining to marriage functions scheduled after 6PM on or before 30th April, 2021, which shall continue to be permitted subject to certain conditions.

Now, therefore, in pursuance of the above-said clarification on marriage-related functions of the Government of Punjab, I, Deepti Uppal, IAS, District Magistrate, Kapurthala, by virtue of the powers vested in me under Section 144 of the Code of Criminal Procedure (Cr. PC), 1973; Section 30 of the Disaster Management Act, 2005, and Section 2 of the Epidemic Diseases Act, 1897, hereby, order that the marriage functions scheduled after 6PM on or before 30th April, 2021, shall continue to be permitted within the territorial jurisdiction of District Kapurthala, subject to the following conditions:

1. Not more than twenty (20) persons shall be allowed to attend the marriage;
2. Attendees shall have to get a Curfew Pass issued from the respective Sub-divisional Magistrate (SDM) in whose jurisdiction the marriage function is being organized;
3. Function should conclude by 9:00PM.

The above directions shall only be applicable to marriages scheduled after 6PM on or before 30th April, 2021.

It is further directed that the dates/timings of all marriages scheduled on or after 1st May, 2021 may be rescheduled by the respective families to bring them in conformity with the prevailing COVID-19 restrictions.

Any violation of this Order shall be punishable under Sections 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the Indian Penal Code (IPC), 1860.
