ORDER:

This is in continuation of the earlier Order of the undersigned issued vide this Office Endst. No. 3232-3285/MA dated 07.05.2021.

Keeping in view the instructions of the Department of Home Affairs & Justice (Home-4 Branch), Government of Punjab, and taking cognizance of the representations & requests received from various quarters, and taking into account the prevailing COVID-19 situation in the District, I, Deepthi Uppal, IAS, District Magistrate, Kapurthala, exercising the powers conferred under Section 144 of the Code of Criminal Procedure (Cr. PC), 1973, do, hereby, order the following amendments to the above-referred to Order dated 07.05.2021:

1. Shops in the district will Open as per following schedule:

| S. No. | Name of the Shop / Trade | Timing | Days |

| 1. | Karyana, <i>Subzi</i> /Fruit Shops | 8AM to 12Noon | Monday to Friday |
| 2. | Milk/Dairies | 8AM to 12Noon, and 3PM to 5PM | Monday to Friday (with <u>Home Delivery</u> at the same timings i.e. <u>from 8AM to 12Noon & 3PM to 5PM on Saturday & Sunday</u>) |
| 3. | All other categories shops except those mentioned in S. No. 1 and 2 | 12Noon to 4PM | Monday to Friday |
| 3 | Medicine Shops of all categories (Wholesale/Retail), All kind of Medical/Health Activities, Petrol/Diesel Pumps & LPG Agencies/Distributors | 24X7 | All Week Days |

- Note: (i). It is made clear that *Subzi* & Fruit *Mandis* in the district will be closed by 12Noon positively;
(ii). No *Rehris* are allowed to park at any particular place and they should have to sell Fruits / *Subzi* by moving around the streets up to 4.00 PM.
2. All Restaurants (including those in Hotels), Cafes, Coffee Shops, Fast Food Outlets, *Dhabas*, Sweet Shops, Bakeries, etc. to remain closed for Dine-In and may function ONLY FOR HOME DELIVERY till 9:00PM. NO seating is allowed inside Restaurants, Fast Food Joint, Coffee Shops, etc. to be allowed.

All other directions as ordered in the earlier Order issued Vide Endst. No. 3232-3285/MA dated 07.05.2021 remain the same.

This Order shall be applicable within the territorial jurisdiction of District Kapurthala with immediate effect till 15th May, 2021.

Any violation of this Order shall be punishable under Sections 51 to 60 of Disaster Management Act, 2005, besides legal action under Section 188 of Indian Penal Code (IPC), 1860.
