**ORDER:**

This is in furtherance of the directions of the Department of Home Affairs & Justice (Home-4) Branch, Government of Punjab, which were issued vide its letter bearing Memo No. 7/56/2020/2H4/2789 dated 15<sup>th</sup> June, 2021 vide which detailed guidelines were issued to contain and manage the COVID-19 pandemic. These directions were valid up to 25<sup>th</sup> June, 2021. In pursuance of these directions of the Government of Punjab, the undersigned had issued Order bearing Endst. No. 4440–4493/MA dated 15.06.2021, which was partially amended vide Order bearing Endst. No. 4613-4672/MA dated 22.06.2021. Both these Orders were valid up to 25<sup>th</sup> June, 2021.

Now, the Department of Home Affairs & Justice (Home-4) Branch, Government of Punjab, vide its letter bearing Memo No. 7/56/2020/2H4/2896 dated 25<sup>th</sup> June, 2021, has extended the restrictions till 30<sup>th</sup> June, 2021 with additional relaxation for IELTS Coaching Institutes, which can now open provided their Teachers, Staff & Students have had at least one (01) dose of Vaccination.

Therefore, in pursuance of the Government of Punjab's above-mentioned Memo No. 7/56/2020/2H4/2896 dated 25<sup>th</sup> June, 2021, and in furtherance of the earlier Orders of the undersigned bearing Endst. No. 4440–4493/MA dated 15.06.2021 and Endst. No. 4613-4672/MA dated 22.06.2021, I, Deepti Uppal, IAS, District Magistrate, Kapurthala, exercising the powers conferred under Section 144 of the Code of Criminal Procedure (Cr. PC), 1973, do, hereby, order to impose the following restrictions to be strictly & meticulously enforced within the territorial jurisdiction of District Kapurthala with immediate effect from 26<sup>th</sup> June till 30<sup>th</sup> June, 2021:

**I. RESTRICTIONS:**

(i). Daily Night Curfew from 8PM to 5AM to be imposed throughout the District, but all the essential activities including those covered in the Para 2 titled, “*Exemptions*” to continue to remain unaffected, unhindered and exempted from Curfew Restrictions.

(ii). All Restaurants (including in Hotels), Cafes, Coffee Shops, Fast-Food Outlets, *Dhabas*, etc., Cinemas, Gyms, Museums to be opened at maximum 50% capacity, subject to all their employees having received at least one (01) dose of vaccination.

(iii). IELTS Coaching Institutes can be opened, provided their Teachers, Staff & Students have had at least one (01) dose of vaccination.

(iv). **Timing/Schedule for Shops & other Commercial Establishments:**

Shops & other commercial establishments viz. Restaurants (including in Hotels), Cafes, Coffee Shops, Fast-Food Outlets, *Dhabas*, IELTS Coaching Institutes, etc., in District Kapurthala will Open as per following Schedule:

**Note:** While the Restaurants (including in Hotels), Cafes, Coffee Shops, Fast-Food Outlets, Dhabas, etc shall close by 8PM, the Home Delivery can be made till 10PM daily.

- (v). Bars, Pubs and 'Ahatas' to remain closed.
- (vi). All Educational Institutions i.e. Schools and Colleges to remain closed.
- (vii). No gathering of people more than fifty (50) persons to be allowed, including for Weddings/Cremations/Funerals.
- (viii). Non-AC Buses may operate to capacity but no standing allowed. AC Buses to be at maximum 50% of capacity.

## 2. EXEMPTIONS:

The following Activities / Establishments shall, subject, however, to observing COVID-19 Appropriate Behaviour by all concerned, remain exempted from COVID-19 Restrictions in Para 1 above:

- (i). Hospitals, Veterinary Hospitals, and all Establishments, both in Public & Private Sector, related to Manufacture & Supply of all Medicines & Medical Equipment, including the Manufacturing & Distribution units such as Dispensaries, Chemists & Pharmacies (including *Jan Aushadhi Kendras*), Laboratories, Pharmaceutical Research Labs, Clinics, Nursing Homes, Ambulances, etc. Transportation of all personnel of these Establishments shall be allowed subject, however, to production of Identity Cards.
- (ii). Shops dealing with Supply of Essential Goods, Milk, Dairy and Poultry Products like Bread, Eggs, Meat, etc. and Vegetables, Fruits, etc.
- (iii). Shops / Establishments selling Industrial Materials including Raw Materials, Intermediaries, as well as Shops / Establishments engaged in Export & Import Activities.
- (iv). Activities / Establishments related to Fisheries such as Fish, Meat and its products including Supply of Fish Seeds.
- (v). 'To & Fro' movement of passengers travelling by Air, Trains and Buses on production of Travel Documents, Inter and Intra-State Movement of all Vehicles/Persons carrying Essential & Non-Essential Goods subject, however, to verification of Point of Origin & Destination.
- (vi). Delivery of all Essential Goods including Food, Pharmaceuticals, Medical Equipment, etc. through E-Commerce.
- (vii). Construction Activities in both Urban & Rural Areas.
- (viii). Agricultural including Procurement, Horticultural, Animal Husbandry and Veterinary Services.
- (ix). Vaccination Outreach Camps.
- (x). Activities of Manufacturing Industry, Commercial & Private Establishments & Services given below including Movement of all their Employees / Workers and Vehicles carrying them upon production of requisite permission from their employers:
  - (a). Telecommunication, Internet Services, Broadcasting & Cable Services, IT & IT-enabled Services.
  - (b). Delivery of all Essential Goods including Food, Pharmaceuticals, Medical Equipment, etc. through E-Commerce.
  - (c). Petrol Pumps and Petroleum Products, LPG, Petroleum & Gas retail & storage outlets, Coal, Firewood & Other Fuels.
  - (d). Power Generation, Transmission & Distribution Units & Services.
  - (e). Cold Storage & Warehousing Services.
  - (f). Private Security Services.
  - (g). Farming Operations by Farmers & Farm Workers in the field.
  - (h). All Banking / RBI Services, ATMs, Cash Vans and Cash Handling / Distribution Services.

3. All the extant directives of the Ministry of Home Affairs (MHA), Government of India; Government of Punjab & District Administration, Kapurthala on COVID-appropriate behaviour including Social Distancing norm of maintaining minimum six (06) feet distance (*Do Gaz Ki*

*Doori*), regulating crowds in marketplaces and public transport, and imposition of penalties prescribed for violation of COVID-appropriate behaviour like wearing of face masks, spitting in public places, etc. shall be strictly enforced.

This Order shall be applicable within the territorial jurisdiction of District Kapurthala with immediate effect from 26<sup>th</sup> June till 30<sup>th</sup> June, 2021.

Any violation of this Order shall be punishable under Sections 51 to 60 of Disaster Management Act, 2005, besides legal action under Section 188 of Indian Penal Code (IPC), 1860.
