ORDER:

This is in furtherance of the order of the undersigned issued vide office Endst.No.7292-7346/MA dated 14.10.2021, which was issued in pursuance of the guidelines of the Department of Home Affairs and Justice (Home-4 Branch), Govt of Punjab that were issued vide letter no. 7/56/2020/2H4/5291 dated 14.10.2021.

Now, the Department of Home Affairs and Justice (Home-4 Branch), Govt of Punjab, vide it's letter bearing no.7/56/2020/2H4/5441 dated 26.10.2021, has made partial modification in para b and para c of it earlier letter no 7/56/2020/2H4/5291 dated 14.10.2021.

Therefore, in pursuance of the above-said guidelines of the Govt of Punjab dated 26.10.2021, I, Deepti Uppal, IAS, District Magistrate, Kapurthala, by virtue of the powers vested in me as per Section 144 of Cr.PC, hereby, modify following restrictions in para (b) and para (c) of my earlier order issued vide Endst. No7292-7346/MA dated 14.10.2021.

Para (b) Gatherings shall be restricted to not more than 500 persons indoors and 700 persons outdoors subject to an upper limit of 50 % of the capacity. Artists/ musicians shall be allowed at such functions/celebrations in all areas with due COVID protocols.

Para(c) Those organizing and managing festival gatherings shall ensure that only that staff is physically present who are either fully vaccinated or have had at least one dose of vaccine over 4 weeks ago. In addition, there shall also a limit to crowd gathering for any purpose to a maximum of 700 individuals at any given point, with proper COVID appropriate behaviour and social distancing norms. These norms shall be mandatory for all crowded gatherings including those by political parties for rallies and meetings.

All other directions as ordered in the earlier order issued vide Endst.No.7292-7346/MA dated 14.10.2021 will remain the same. Senior Superintendent of Police (SSP), Kapurthala and concerned Sub Divisional Magistrates shall ensure implementation of above-said orders.

This order shall be applicable within the territorial jurisdiction of District Kapurthala with immediate effect till 31st October,2021.

Any violation of this Order shall be punishable under Sections 51 to 60 of Disaster Management Act, 2005, besides legal action under Section 188 of Indian Penal Code (IPC), 1860.
