**ORDER:**

WHEREAS, Covid-19 has already been declared as a pandemic by the World Health Organization (WHO) and now the cases of Covid-19 are increasing in the district and state, hence this office has already issued restrictions order 55-109/MA dated 04-01-2022. Election Commission of India has announced election of Punjab Legislative Assembly 2022 on 08/01/2022 and date of poll is 14/02/2022.

WHEREAS, it is expected that all stakeholders namely political parties, candidates, campaigners, voters and authorities engaged in the election process shall always be conscious of their prime duty towards public health/safety and therefore shall abide by these general instructions and other norms of Covid appropriate behavior as mandated by the respective authorities.

Therefore, I, Deepti Uppal, IAS, District Magistrate, Kapurthala in exercise of powers conferred under Section 144 of Cr.PC, 1973 and National Disaster Management Act, 2005, issue following orders in the District Kapurthala. These orders will remain in force in the District Kapurthala till 15-01-2022:

1. No Road Show, Pad-Yatra, cycle/bike/vehicle rally and procession shall be allowed till 15 January, 2022. Commission shall subsequently review the situation and issue further instructions accordingly.
2. No Physical Rally of Political parties or probable candidates or any other group related to election shall be allowed till 15 January, 2022. Commission shall subsequently review the situation and issue further instructions accordingly.


Any violations of this order shall be punishable under Sections 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of Indian Penal Code (IPC), 1860.

Sr. Superintendent of Police Kapurthala and all SDM's shall ensure implementation of this order in letter and spirit.
