**ORDER:**

It has been brought into the notice of the undersigned by the Civil Surgeon Kapurthala vide her office letter bearing No. IDSP/KPT/2022/58 dated 14.01.2022 that six (6) active positive cases of COVID-19 have been confirmed in **Girls Hostel No 1, Block No 9 and Boys Hostel No 6, Block No 54 in Lovely Professional University, Phagwara District Kapurthala** area under SDH, Phagwara of Phagwara Sub-Division, and as per protocol and advisory received from the Ministry of Health & Family Welfare (MoHFW), Government of India, it appears to me that these cases can affect the surrounding areas and pose a potential threat to the nearby areas/localities.

Now, therefore, I, Deepti Uppal, IAS, District Magistrate, Kapurthala, by virtue of the powers vested in me under the Disaster Management Act, 2005 and the Epidemic Diseases Act, 1897, declare that **Girls Hostel No 1, Block No 9 and Boys Hostel No 6, Block No 54 in Lovely Professional University, Phagwara District Kapurthala** area under SDH, Phagwara of Phagwara Sub-Division, District Kapurthala as a Micro-Containment Zone for checking, preventing and controlling the spread of COVID-19.

This order shall take effect at once.

Whereas, to deal with the situation and effective implementation of the Containment Measures, the following tasks are assigned to the officials mentioned below:

**1. Sub-Divisional Magistrate (SDM), Phagwara:**

- Will be the Supervisory Officer for the administrative control of the area under containment, with the purpose of breaking the chain of transmission, and thus preventing its spread to other areas;
- Providing local nearest available medical/administrative facility.
- Will be responsible for posting signs and creating awareness informing the public about the perimeter control.
- Will be responsible for the field staff brought in for surveillance activities, and that for providing perimeter control need to be accommodated within the containment zone. Facilities such as Schools, Community Building(s), etc. will be identified for providing shelter. Catering arrangement(s) will need to be made at these locations.
- Will be responsible for updating the District Control Cell with the real-time and consolidated information/data at designated intervals.
- For supply of essential commodities in the area.
- Will ensure that the staff of all the concerned departments is present as per the roster, which shall be prepared by the District heads of the departments concerned.

**2. SSP, Kapurthala (through Superintendent of Police, Phagwara):**

- Implementing and enforcing Social Distancing measures (06 feet or *Do Gaz ki Doori*) and cordoning-off the area under containment, and sealing all Entry & Exit points. The perimeter control will ensure that there is no unchecked outward movement of population from containment zone except for maintaining essential services (including medical emergencies and Govt/Business continuity).

**3. CMO/SMO/Staff of Health Department:**

- Responsible for Testing of suspect samples and providing necessary medical facilities.
- Establishing surge capacities for isolating all suspects/confirmed cases for medical care.
- Active surveillance carried out daily through ASHA Workers/Anganwari Workers/ANMs.
- They will line list the family members and those having symptoms. The field workers will provide face masks to the suspects and to the care giver identified by the family.
- The healthy workers will be posted at the Exit Points of the area under containment and will perform screening (interview travellers, measure temperature, record the place and duration of intended visit and keep complete record of intended place of stay).

- All vehicles moving out of the perimeter will be decontaminated with Sodium Hypochlorite (1%) solution.

**4. District Mandi Officer (through Secretary, Market Committee):**

- Providing uninterrupted supply of vegetables and fruits in the area under containment.

**5. Commissioner, Municipal Corporation (MC), Phagwara:**

- Providing water supply and the necessary sewerage facilities in the area, along with proper sanitation and thorough cleanliness of the area.

**6. Department of Food Supplies & Consumer Affairs (DFSO through DFSA/AFSA):**

- Providing uninterrupted supply of food items and consumables in the area under containment.

**7. PSPCL (through SDO/SDE/JE):**

- Providing uninterrupted power supply to the area under containment and treatment facility.

**8. PPCB (through SDE/JE):**

- As large quantity of Bio-Medical Waste is expected to be generated from the Micro-Containment Zone, the official will be responsible for discarding the Bio-Medical Waste by utilizing the Bio-Medical Waste Management Services at the designated hospitals.

**9. Department of Animal Husbandry:**

- Providing and ensuring uninterrupted supply of animal fodder.
- Ensure that a Veterinary Doctor is deputed to take care of the health of domestic animals.

The District Heads of all the Departments in District Kapurthala, as indicated above, will ensure round-the-clock duties for carrying out the above tasks/responsibilities, and will be required to submit the roster of duties complete with contact details (name, designation, mobile/phone number) in advance to the District Control Room as well as to Sub-Divisional Magistrate (SDM), Phagwara.

These institutions / officers / employees will follow the COVID-19-related instructions/orders/directions/SOPs issued by the Government of India/Government of Punjab and the District Administration, Kapurthala from time to time. Sub-divisional Magistrate, Phagwara will be the Overall In-charge of the Containment Operations in Girls Hostel No 1, Block No 9 and Boys Hostel No 6, Block No 54 in Lovely Professional University, Phagwara District Kapurthala area under SDH, Phagwara of Phagwara Sub-Division, District Kapurthala.
