2. In terms of SRO-202 of 2015 dated 30/06/2015 further prescribed/ notified as :-
- I. Appointment would be on regular/ temporary basis from the date of appointment.
  - II. The Appointees shall be initially on probation for a period of (5) five years and after completion of probation period his/her service shall be declared as permanent.
  - III. During the period of Ist five years, the appointees shall be entitled to the minimum scale of pay applicable to the post against which he/she is appointed, and shall be entitled to annual increments, D.A, HRA, other Allowances after successful completion of five years service on consolidated salary.
  - IV. The appointees shall be entitled to the benefit under the Medical Attendance Rules and Leave rules from the date of appointment.
  - V. The iner-se-seniority of the appointees shall be fixation in accordance with merit secured by these appointees in the selection list prepared by the LAHD-Subordinate Services recruitment Board Leh Ladakh.
  - VI. The period spent on probation/consolidated salary shall also reckon for purposes of calculating the qualifying service of the appointee for other benefits provided under rules.

3. The appointees shall be allowed to join only on production of the following certificates in original:-

- I. Academic/Technical qualification certificates.
  - II. Matriculation/Date of Birth certificate.
  - III. Health certificate form Chief Medical Officer Leh.
  - IV. Permanent Resident Certificate issued by competent authority.
  - V. Certificate from the District Industries centre (DIC) and District Employment and Counseling Centre, Leh to the effect that no loan under self employment scheme has been taken by the appointee(s).
  - VI. Relevant category certificate.
4. The appointment of the above candidates shall also governed by "New Pension Schemes" as per SRO 400 of 2009, dated 24/12/2009.
5. Each appointee shall give an undertaking duly attested by the Ist Class Magistrate in the shape and affidavit to the effect that in case adverse report about his Character and antecedents is received from Inspector General of Police, (CID) /DIG/District Magistrate, to whom a reference shall be made by the concerned drawing & disbursing officer, the candidates shall have no right to claim their appointment as (Class-IV) Orderly/Chowkidar and their appointment, as such, shall be deemed to have been cancelled ab-initio;
6. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee (s) shall not be drawn and disbursed to them unless the satisfactory reports in respect of (5) and (6) above are satisfactory received in their favour.

The appointment of the above candidates shall be subject to outcome of the writ petition (s) if any, pending before in any court of the competent jurisdiction.
