
In continuation to this office order No. DCL/PS/COVID-19/2020 dated 22.03.2020 and No. DCL/PS/COVID-19/2020-60-62 dated 26.03.2020, it is hereby ordered that:

1. The Mahabodhi Charitable Hospital(MKCH), Leh is declared as COVID-19 Hospital and all necessary facilities shall be put in place by the District Administration, Leh.
2. Sh Dr Mohd Baqir, Chief Animal Husbandry Officer, Leh is appointed as Nodal Officer at the MKC Hospital and shall be responsible for smooth coordination and facilitation on behalf of the District Administration, Leh.
3. Sr Superintendent of Police Leh shall provide adequate security arrangements.
4. Chief Medical officer, Leh shall provide the Paramedics and other necessary medical requirements.
5. Executive Engineer PHE/R&B/Const/Mechanical under overall supervision of District Superintending Engineer, PWD, Leh shall ensure the basic facilities, repair/renovations(Wherever needed) at the above location.
6. Additional District Magistrate shall issue Vehicle/Individual passes to the Nodal Officer.
7. Assistant Labour Commissioner, Leh shall depute the labourers as and when needed by the Nodal Officer.
8. Chief Agriculture Officer/Chief Horticulture Officer, Leh shall keep their men and machinery ready to sanitize the designated Hospital as and when asked by the designated Nodal Officer.
9. SDM Kharu shall be responsible for arrangement of food by way of Tiffin services.
10. ARTO, Leh/DD DMG, Leh shall be responsible for transportation arrangements.

Additional DC, Leh shall be the overall incharge of the MKC, Hospital.
