Whereas consequent upon the formation of Ladakh as Union Territory in terms of Jammu and Kashmir Re-Organization Act 2019, various posts (Gazetted / Non-Gazetted) were **allotted/allocated under UT Cadre only** by the Tourism Department, Jammu and Kashmir Vide SRO: 911 of 2019 (Gazetted Tourism) and SRO-912 of 2019 (Non-Gazetted Tourism), 915 of 2019(Gazetted Dev. Authorities) & 916 of 2019 (Non-Gazetted Dev Authorities) Dated: 26.10.2020; and

Whereas, General Administration Department, UT of Ladakh vide circular No: 05-LA(GA) of 2020 Dated: 24.06.2020 read with letter No: LA(Circular)UTL/2019(01) 1020-1024 Dated: 06.07.2020 and minutes of meeting issued under endorsement No: LA/GAD(Meeting)UTL/2019(05) 1093-1101 Dated: 16.07.2020 passed on the instructions inter-alia directing for Notification of Tentative Seniority lists of officers/officials belonging to different cadres of the concerned Departments who have exercised option for UT of Ladakh under section 89 of the aforesaid Act: and

Whereas perusal of previous record and seniority lists notified from time to time reveal that the seniority lists of Non-Gazetted Staff(Executive and Ministerial) used to be notified by Directorates of Tourism of Erstwhile Jammu and Kashmir State incorporating the staff of Tourism Development Authorities other than those posted on deputation basis ; and

Whereas procedure being followed previously is to be adopted in formulation and notification of seniority of all the Posts/cadres in order to avoid any dispute which may arise among the members of Cadre in the Department; and

Whereas the particulars of Officers/Officials of UT Ladakh have been compiled in the Directorate on the basis of details received from CEOs Tourism Development Authorities

of Ladakh /Assistant Directors Tourism Leh/Kargil and pending formal allotment/allocation of officers/officials under Section 89 of the J&K Re-Organization Act-2019, Tentative Seniority as stood on 25.07.2020 in respect of Non-Gazetted (Executive and Ministerial) Staff (other than officers / officials working in Development Authorities on deputation basis) in Tourism Department/Tourism Development Authorities of UT Ladakh opted for UT of Ladakh under Section 89 of J&K Re-Organization Act 2019 has been formulated and enclosed as Annexure "A" to this notice; and

Now, therefore, an Updated Tentative Seniority List of Non-Gazetted (Executive & Ministerial) staff of UT Cadre who have opted for UT of Ladakh under Section 89 of J&K Re-organization Act 2019 is hereby notified as **Annexure "A"** to this notice and is circulated for inviting objections, if any, from the concerned member(s) of service/cadre who are eligible to be included in the list and have opted for UT of Ladakh but could not be included in list inadvertently or due to non availability of the particulars or whose service particulars are not correct or those who have been included in the tentative list but not opted for UT of Ladakh. The Tentative Seniority List, however, is issued without prejudices to the outcome of Writ Petition pending consideration before any Hon'ble court and subject to further inclusion/exclusion consequent upon formal allotment/allocation of officer(s)/official(s) under Section 89 of Jammu and Kashmir Re-Organization Act 2019.

The objections/representations, if any, along with authenticated documentary proofs/ bio-data be submitted within 15 days from the date of issuance of this notice through their Controlling Officer/ Chief Executive Officers/ Assistant Directors Tourism, so as to reach this Directorate within stipulated time. No objection in this regard shall be entertained after the expiry of stipulated time and final seniority shall be notified without any further notice.
