The tenders shall be opened on the next day of the last day of receipt of tender or any other subsequent day convenient to Block Development Officer, Kharu in presence of the tenderers who may like to be present at that time. The Block Development Officer, Kharu reserve the right to accept or reject the entire tender or any of them without assigning any reason thereof.

The last date of issuance of documents has been fixed on 13/10/2020 and can be had from the Block Development Office, Kharu up to 4:00 pm.

Terms and Conditions:-

1. The tenderers should use the prescribed form attached with the tender documents duly issued from the office of the undersigned.
2. The D class contractors / entrepreneur / individual fulfilling the eligibility conditions/criteria as per Annexure "A" to Order No. 88-LA(ORDER)UTL Of 2020, Dated: 23-07-2020 must have GST registration number.
3. The intending tenderers are advised to visit the site of work as mentioned above at their own cost/responsibility to acquaint themselves with site conditions for quoting genuine and workable rates.
4. The intending tenderers shall attend with their registration card duly renewed and entrepreneur / individual should attend with the documents enlisted in Annexure "A" of above mentioned Order. The tenderers shall make sure that the tender reaches in the office of the Block Development Officer, Chuchot before the prescribed date and time.
5. Any tender reaching after expiry of prescribed date and time shall not be received /entertained.
6. The tender shall be valid for 90 days from the date of opening of same by the competent authority.
7. GST, income tax, Cess and other taxes in vogue during the current execution year shall be deducted at source.
8. The tender shall be rejected in case the contractor, entrepreneurs/individuals as per Annexure "A" to mentioned Order fails to record his/her signature on the rate list.
9. Contractor/entrepreneurs/individuals as per Annexure "A" to mentioned Order, in case of bid of the lowest bidder is found unbalanced, the successful bidder shall have to produce additional performance security in shape of FDR, CDR or bank guarantee before fixation of contract.
10. The earnest money shall be fortified:
 - a) If the contractor withdraws or amend tender or derogates from the tender in any respect within the period of validity of tender.
 - b) If the successful tenderer fails to furnish required act of performance as per the terms and conditions of tender/contract.
11. The date of start of the work shall be reckoned within one week from the date of issuance.
12. Penalty for delay in completion: in case of delay in completion of work beyond stipulated period of completion, penalty up to maximum of 10% of the contract shall be imposed.
13. It is mandatory to submit GST supporting voucher at the time of billing.
14. All other terms and conditions shall remain as laid down in the PWD form 25 (Double leaf).
