**O R D E R**

Consequent upon reporting of a cluster of COVID-19 Positive cases from SECMOL Campus Phey, the entire campus is hereby notified as Containment Zone w.e.f. 03-05-2021.

1. The Senior Superintendent of Police, Leh shall ensure strict perimeter control of the areas as per containment plan issued by the Ministry of Health and Family Welfare, GOI.
2. The Chief Medical Officer, Leh shall ensure active surveillance and aggressive contact tracing and sampling as per prescribed guidelines to contain further spread of the Corona Virus.
3. For the purpose of supplies of Essential/Non-Essential Commodities within the Containment Zone, **Sh. Mohd. Rahullah, Naib Tehsildar, Chuchot (9469459746)** shall be the Nodal Officer and Sh. Motup Patwari, PH Phyang shall be the Assistant Nodal Officer, who shall coordinate with the office of the undersigned for any requirements/emergencies within the containment zone. 4. There shall be complete restriction on inward & outward movement from / to the containment zone.
5. All the work places within the containment zone shall remain closed till further orders.
