Subject: SOPs/Guidelines for COVID Management in Leh district.

O R D E R

WHEREAS, the Secretary MoHFW, GOI vide D.O No. Z.28015/85/2021-DM Cell Dated 25-04-2021 has advised all District Magistrates to undertake containment measures to restrict intermingling amongst people so that spread of infection can be controlled.

WHEREAS, detailed assessment of the current COVID situation in Leh district has been conducted by the DDMA, Leh in light of current trend of COVID cases, Positivity Rate, and Hospital admissions etc., and are of the clear view of further extension of restrictions which are already in place to avoid further spread of the Corona Virus.

NOW THEREFORE, in view of the above, I, Shrikant Balasaheb Suse, IAS, District Magistrate, Leh in exercise of the power conferred upon me as Chairman, District Disaster Management Authority under section 34 of Disaster Management Act 2005, as well as under Section 144 CrPC, 1973, Epidemic Disaster Management Act, 1897, and in partial modification of this office order issued vide No. DCL/PS/COVID-19/00/2021-1198 dated 12.06.2021, hereby order the following relaxations w.e.f. **21-06-2021 (Monday) 05:00 A.M, till 28-06-2021 (Monday); 05:00 A.M.**

1. All Shops/Business establishments/related movements shall be allowed as per the following details:

ii.	Armed/Paramilitary Forces, Telecom services and related infrastructure, Print & electronic media, Fuel/LPG, Beneficiaries of Vaccination & sampling, Staff on COVID Duty, Staff on Airport duty.		
iii.	Hardware Shops & Stores dealing with construction materials along with the vehicles needed for transportation.	All days	05:00 AM to 01:00 PM
iv.	Groceries/General Stores, Fruits/Vegetable/Milk products Meat/Chicken Shops, Nanwai, and Bakeries.	All days	07:00 AM to 05:00 PM
v.	Readymade Garments/Shoe, Tailoring, Home furnishing items / Furniture shops.	All days	01:00 PM to 08:00 PM
vi.	Workshop/Service, Tyre Stations, Spare part repair, Automobile Showrooms/Shops, Travel & Tours/Ticket booking agencies.		
vii.	Mobile repair, Electronic Appliances, IT & Computer Shops, DISH/TV recharge shops/Kiosks.		
viii.	Printing Press, Photo-state, Stationeries/Book/ Sports, Toys/Gift Shops, Crockery, Cosmetic, Souvenir / Arts shops, Jewellery/Goldsmith. Left out Shops/Business establishments, if any.

2. Vehicular movements shall be allowed all days with **50% of the seating capacity of vehicle.**
3. Restaurants & Bars shall be allowed to operate all days with **50% of the seating capacity from 7 AM to 9 PM.**
4. Private offices shall be allowed to open with strict observance of COVID Appropriate Behaviour (CAB).
5. E-Commerce services shall be allowed to open all days from **7 AM to 8 PM.**
6. Hotels shall operate their dine-in facilities with **50% of their seating capacity** and room services shall be encouraged as far as possible.
7. Development activities and construction works shall continue to be allowed with the minimal movement of labourers/workers. The executing agencies/contractors shall ensure onsite facilities for the Labourers/workers and ensure observance of all COVID-19 SOPs issued from time to time.
8. Night Curfew for non-essential services shall continue to remain in force for all days between **10:00 PM to 05:00 AM.**
9. All above relaxations shall be subject to strict observance of all COVID Appropriate Behaviour (CAB) Viz. Wearing of Facemask, Maintaining Social Distancing, Provision of Thermal Scanning, Hand Wash Facility/Hand Sanitizer, and regular disinfection of Shops, Restaurants, Halls, Workplaces, and other Business Establishments etc.
10. **Relaxations allowed in this order shall not extend to the areas notified as containment zone in entire district.**
11. The Sr. Superintendent of Police, Leh and Chief Executive Officer, DDMA (Addl. District Magistrate, Leh), ARTO, Traffic Police, Sub Divisional Magistrates, Executive Magistrates 1st class, COVID SOPs Enforcement Squads shall ensure implementation of the above directives in letter and spirit.
12. Since it is not possible to serve prior notice of this order, it is as such issued ex parte.

Any violation of the above directives, penal action under Section 51 of Disaster Management Act, 2005 and Section 188 of IPC, and other relevant laws shall be initiated.
