Subject: - COVID management in Leh district.

ORDER

Given the sudden influx of tourists into Leh district and in order to ensure stringent implementation of the COVID SOPs/Guidelines and precautionary measures in place, following measures are hereby ordered in addition to the existing COVID mitigation arrangements to be implemented by the concerned in letter & spirit:

1. Rigorous fining shall be made by the Joint Special Enforcement Squads consisting of the Duty Magistrates and Police Officers. **(The COVID Special Enforcement Squads comprising of the Duty Magistrates & Police Officers stand constituted vide this office's order No. DCL/PS/COVID-19/00/2021-990 Dated 01.04.2021 & Corrigendum order No. 995 Dated 03.04.2021).**
2. The Sub Divisional Magistrates shall constitute/reactivate a joint enforcement Squads comprising of the officers/officials of Revenue and Police department.
3. The above mentioned squads shall ensure stringent implementation of the COVID SOPs & precautionary measures in place Viz. wearing of Facemask, maintain social distancing, frequents hand washing using of hand sanitizer, marking of circle outside the Shops/Business establishments, etc.
4. The Squads shall conduct mass fining of the COVID violators especially in the public places, tourists spots, and other vulnerable areas.
5. A daily report shall be submitted to the undersigned on the action taken report on the format already devised by this office.
6. The daily reports should be submitted through the COVID Command Centre, Leh without fail.
