It is notified for the information of all the candidates eligible for written test for the post of **Amchi Librarian in Health Department, Leh** vide Advertisement No. 02 of 2019 dated: 05-03-2019 and **Electrician/ Technician III in Chief Engineer Generation/ wing (JKSPDC/JKPDD) Ladakh** vide Advertisement No. 01 of 2019 dated: 09-01-2019 which was postponed vide this office notification issued under endorsement No: DE&CCL/LAHD-SSRB/WGFG/21/1738-66 dated:20-04-2021, now shall be held as per following schedule:-

Important Note:

Candidates are advised to strictly adhere to the following instructions;

1. Candidates should, in addition to their Admit Card, bring at least one photo identity proof in original with clear photograph (e.g. Aadhar card, Driving License, University/College ID, Election card, PAN Card etc). Candidates without hard copy of admit card shall not be allowed to appear in Written Test.
2. Books, calculators, paper chits, magazines, mobile phones, Bluetooth devices, head phones or any electronic gadgets, are **STRICTLY PROHIBITED** and **NOT ALLOWED** in the examination Centre. If any such item is found after the commencement of examination, whether in use or not, will be deemed to be using unfair means and his/her candidature is shall be cancelled and legal/criminal proceedings will be initiated against him/her. Moreover, he/she would also liable to be debarred from appearing in future examination of the Leh Autonomous Hill Development Sub-Ordinate Services Recruitment Board.
3. Candidates are advised not to bring the prohibited items mentioned above in the examination centre. In case they bring any such item, they would have to make their own arrangements for safe custody of such items. The LAHD-SSRB shall not make any such arrangement nor be responsible for the safe custody of any such item.
4. A candidate found guilty of impersonation, making statements which are incorrect or lobbying shall be debarred from appearing in future examinations of



- the Leh Autonomous Hill Development Sub-Ordinate Services Recruitment Board and also be liable for legal/criminal proceedings initiated against him/her.
5. Candidates are advised to approach examination centre two hours before the commencement of exam. However, they will be allowed to sit in the examination Hall/Room 30 minutes prior to exam. No candidate shall be allowed to enter the examination Hall/Room after the commencement of the exam.
 6. Candidates are warned not to write any irrelevant matter, any sort of appeal, criticism of question paper, salutation, sign or invocation to God, etc in the answer sheet other than required data on first page and tick mark (✓) for the answer. Rough sheet is appended at last page of answer sheet. Violation of this instruction shall tantamount to use of unfair means and will attract punishment which may include debarring from appearing in the examination.
 7. Candidates are also advised to bring card board, blue or black ballpoint pen, drinking water bottle, etc. No borrowing or exchange of articles would be allowed in the examination Room/hall. Further, candidates are advised to bring their own mat.
 8. No candidates are allowed to leave the examination Hall/Room for any reason without permission from the examination functionaries. If any candidate is found obstructing the conduct of the examination, creating nuisance at the examination venue or misbehaving with the officials on duty, his/her candidature shall be instantaneously cancelled and shall liable to be debarred from future examination of the LAHD-SSRB and legal/criminal proceedings could be initiated against him/her.
 9. If the examination is rescheduled due to deteriorating Covid-19 situation, the candidates shall be intimated well in advance.
 10. If the examination does not commence at the scheduled time due to some reasons, candidates should follow the instructions of the exam functionaries. They may have to wait patiently till the issue is resolved. In case, the problem is unavoidable, their examination may be rescheduled, for which the candidates would be duly intimated.
 11. In case of any doubt or clarification, the candidates are advised to approach to the office of the Secretary LAHD-SSRB personally.

Note: Candidates are hereby directed that wearing of mask is mandatory during written test and also advice to carry hand sanitizer for their personal use and shall follow all Covid-19 appropriate behaviour.
