**Subject: - Unlock 2021 - SOPs/Guidelines for COVID Management in Leh district.**

**O R D E R**

In continuation to this office order No. DCL/PS/COVID-19/OO/2021-1240 dated 26.06.2021 followed by extension order No. DCL/PS/COVID-19/OO/2021-1249 dated 04.07.2021 on the subject mentioned above, it is hereby ordered that all the restrictions imposed vide above mentioned order shall continue to remain in force with following additional relaxations, which shall come into force with effect from 12.07.2021 (Monday) 5 AM till further order:

1. Chemist Shops, Ayurvedic Shops, Diagnostic Centres, Medical & Clinical Establishments, Opticians, and Laboratories etc. shall be allowed to remain open 24X7 on all days.
2. All other Shops and Business establishments including Restaurants, Dhabas, Bars, Wine Shops, Gymnasiums, Spas, Barber Shops/Beauty Salons, etc. shall be allowed to operate from 5 AM up to 9.30 PM on all days.
3. The Sr. Superintendent of Police, Leh, Chief Executive Officer, DDMA (Addl. District Magistrate, Leh), ARTO, Traffic Police, Sub Divisional Magistrates, Executive Magistrates 1st class, COVID SOPs Enforcement Squads shall ensure implementation of the above directives in letter and spirit.
4. Any violation of the above directives, penal action under Section 51 of Disaster Management Act., 2005 and Section 188 of IPC, and other relevant laws shall be initiated.
