Consequent upon reporting of cluster of COVID-19 positive cases from Gotur House, Adjacent to Tsuru, Sankar, Leh the said location is hereby notified as Micro Containment Zone as a measure to contain further spread of the Corona Virus.

1. The Senior Superintendent of Police, Leh shall ensure strict perimeter control of the area as per containment plan issued by the Ministry of Health and Family Welfare, GOI.
2. The Chief Medical Officer, Leh shall ensure active surveillance and aggressive contact tracing and sampling as per prescribed guidelines.
3. For the purpose of supplies of essential/non-essential commodities, **Sh. Abdul Wahid, Naib Tehsildar, Settlement, Leh (9797546436)** shall be the Nodal Officer, who shall coordinate with the office of the undersigned for any requirements/emergencies within the micro containment zone. Any violation of the above directions shall invite strict action under relevant sections of Disaster Management Act, 2005.
