

District Magistrate-cum-Chairman, DDMA, Charkhi Dadri**ORDER**

Whereas the State Disaster Management Authority, Haryana, Chandigarh has issued revised SOPs for social/academic/sports/entertainment/cultural/religious/political functions and other congregation vide memo no. DMC-SPO-2021/6221 dated 06.02.2021 (copy enclosed along with enclosures) with reference to Order dated DMC-SPO-2020/8428 dated 19.12.2020, as under:-

- 1- In closed spaces, a maximum of 50% of the hall capacity will be allowed with no ceiling of persons i.e. 500 persons in the hall capacity of 1000, 250 persons in the hall capacity of 500 and 100 persons in the hall capacity of 200.
- 2- In open spaces, there is no limit/bar for gathering, however, it shall be allowed keeping in view the capacity of the place to accommodate the people so that all the social distancing norms issued by Minister of Home Affairs (MHA) & Ministry of Health & Family Welfare (MoHFW), Government of India and Government of Haryana from time to time viz., mandatory wearing of face masks, hand wash or sanitizer and provision for thermal scanning, etc., can be followed.

And whereas, it has been further directed that the organizers of social, academic /sports /entertainment /cultural/religious/political functions and other congregation gatherings shall take prior permission of District Magistrates. The District magistrates will issue permissions after seeking necessary NOCs from the concerned Departments including police.

Now, therefore, I, **Dr. Rahul Narwal, IAS, District Magistrate-cum-Chairman, DDMA, Charkhi Dadri**, in exercise of the powers conferred by Section 30 of the Disaster Management Act, 2005 direct all the concerned officers/officials in the District of Charkhi Dadri, to strictly comply with the above instructions meticulously, issued by the State Government.

The following joint inspection teams for enforcing the above instructions/directions to ensure extensive checking and action against the violators as per law/rules/instructions/directions issued from time to time by the State Government of Haryana.

Additional Deputy Commissioner, Charkhi Dadri will be overall in charge for strict enforcement of the above measures in the district of Charkhi Dadri.

It is further directed that the Superintendent of Police, Charkhi Dadri, District Revenue Officer, Charkhi Dadri and District Development & Panchayat Officer, Charkhi Dadri shall ensure the compliance of this order.

Any person violating this order will invite immediate penal action under Section 51 to 60 of Disaster management Act, 2005 besides legal action under Section 188 of the IPC, as per National Directives and the offences and penalties for violating measures, as enclosed with the MHA order dated 27.01.2021 (Annexure-A) in the form of Annexure I & II.

It is also clarified that the directions of Ministry of Home Affairs (MHA), Government of India regarding guidelines for Surveillance, Containment and Caution issued dated 27.01.2021 and consequent SOPs released by Ministry of Health & Family Welfare (MoHFW), Government of India should not be diluted in any manner, whatsoever, while complying with these Standard Operating Procedure (SOPs).

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the Public at large.

The order shall be promulgated in the area of district Charkhi Dadri by affixing copies of this order on the Notice Boards of District, Sub Divisional, Tehsil Offices, other Public Places, by beat of drum, announcement through the publicity can of Information & Public Relations Department, publications in the newspapers having circulation in the area through the office of the DIPRO, Charkhi Dadri and publicity may also be carried out through social media.

DIO, NIC, Charkhi Dadri is directed to host this order on the official website <https://charkhidadri.gov.in> of district Charkhi Dadri.

Strict compliance of the above directions be ensured by all the concerned.
