

ORDER

In supersession of this office Order Endst. 180/FRA dated 14.04.2021 and in compliance vide Memo No. DMC-SPO-2020/18314 dated 24.04.2021, Haryana State Disaster Management Authority, Chandigarh has issued additional guidelines for containment of COVID-19 Epidemic in the State with immediate effect.

And whereas I am satisfied that immediate measures are needed to be taken for prevention of such danger to human health and safety relating to General Public in District Charkhi Dadri.

Now, therefore, in exercise of the powers vested in me by virtue of Disaster Management Act, 2005, I, **Rajesh Jogpal, IAS, District Magistrate, Charkhi Dadri**, do hereby order that it necessary to take effective measures to prevent its spread in the District Charkhi Dadri. Accordingly, following additional guidelines are hereby issued for containment of COVID-19 Epidemic in the District Charkhi Dadri with immediate effect :-

Social / academic / sports / entertainment /cultural / religious / political functions and other congregation.

In Supersession of Section 5 of Government's earlier order no. DMC-SPO-2020/4584 dated 16.04.2021, Social / Academic / Sports / Entertainment / Cultural / Religious / Political functions and other congregations in the district will be allowed in areas outside the Containment zones only with strict adherence to the appropriate COVID-19 behavior such as social distancing norms, wearing of face masks, sanitization, hand hygiene and provision for thermal scanning, etc. as follows :-


- i. In indoor spaces, a maximum of 50% of the hall capacity will be allowed with a ceiling of **30 persons**. This would also include all Cinemas / Theaters / Multiplexes / Bars / Restaurants / Hotels / Clubs/ Gyms. The capacity of indoor places will be specified by the Urban Local Bodies / Department concerned keeping in mind a calculated correlation between the number of chairs / seating or standing capacity and the covered area in sq. yards / sq.feet.
- ii. In open spaces, gatherings will be allowed with the ceiling of **50 persons**.
- iii. For Funerals and cremations participation will be limited to a maximum **20 persons**.

It has been further directed that the organizers of Social / Academic / Sports / Entertainment / Cultural / Religious / Political functions and other congregation gatherings shall take prior permission of respective Sub Divisional Magistrates. The Sub Divisional Magistrates will issue permissions after obtaining necessary NOCs from the concerned departments.

The public shall be motivated to conduct marriages and other functions during day time only to avoid rush/traffic congestions at the time of commencement of "**Corona Curfew**", by the Additional Deputy Commissioner-cum-Deputy Municipal Commissioner, Charkhi Dadri, Concerned Sub Divisional Magistrates, Deputy Superintendents of Police, COVID-19 Duty Magistrates-cum-Incident Commanders, Tehsildar/Naib Tehsildars, BD&POs, SHOs Secretary, Municipal Council, Charkhi Dadri, Secretary Red Cross, Charkhi Dadri DPO/POICDS Cell, Aanganwari Workers and DIPRO, Charkhi Dadri.


Additional Deputy Commissioner-cum-Deputy Municipal Commissioner, Charkhi Dadri, Superintendent of Police, Charkhi Dadri, Concerned Sub Divisional Magistrates, Charkhi Dadri/Badhra, COVID-19 Duty Magistrates-cum-Incident Commanders, SHO's Secretary Municipal Council, Charkhi Dadri shall be responsible for the strict compliance of the above order.

Any person found guilty for violation of this order shall be prosecuted and punished under section 51 to 60 of the National Disaster Management Act, 2005, beside legal action under Section 188 of the Indian Penal Code, and other provisions as applicable.
