

**DISTRICT MAGISTRATE
CHARKHI DADRI
ORDER UNDER SECTION 65 OF DISASTER MANAGEMENT ACT, 2005**

WHEREAS, the COVID-19 has been declared as pandemic by the World Health Organization and National Disaster Management Authority, being satisfied that the country is threatened with the COVID-19 pandemic.

The Government of Haryana has considered it necessary to take effective measures to prevent and contain the spread of the COVID-19 virus in the state of Haryana including district Charkhi Dadri in the interest of maintenance of public health, hygiene and safety. Directions of the State government vide order no.PS/CS/2021/86-96 dated 27.04.21, and Chairman, National Executive Committee, National Disaster Management Authority have also been received in this regard.

Whereas, it is evident that there has been an exponential surge in the COVID cases in the District Charkhi Dadri, and necessary measures are to be adopted to contain the spread of the COVID-19 and also to ensure that there is minimum collateral damage.


Therefore, now, I Rajesh Jogpal, IAS, District Magistrate, Charkhi Dadri in exercise of the powers vested in me by virtue of Section 10 (2) (1) Section 65, Disaster Management Act, 2005, hereby prohibit the possession of liquid oxygen along with the oxygen cylinders and accessories owned, possessed or rented by any establishment within the jurisdiction of Charkhi Dadri District except for medical use. The stock of liquid oxygen and oxygen cylinders barring the medical use should be deposited at the Civil Hospital, Charkhi Dadri, latest by 29.04.2021 with Chief Medical Officer, Charkhi Dadri. The contravention of the said order shall invite punishment under Section 51 and 57 of the Disaster Management Act, 2005.

Any person contravening this order shall be punishable u/s 188 of Indian Penal Code also. Superintendent of Police, Charkhi Dadri and CMO Charkhi Dadri shall implement and enforce this order and all police officers shall take *suo-moto* cognizance of the violation of this order.

It shall be published for the information of public in general through the press and publicity Van of public relations department and also by affixing copies at notice board of all Offices of the District Administration, Superintendent of Police, District Courts, Office of Deputy Commissioner, District Municipal Commissioner, Charkhi Dadri, Sub Divisional Magistrate, Charkhi Dadri/Badhra, Tehsils, Zila Parishad, Panchayat Samitis, all Police Stations and other prominent places.

This order shall come into force with effect from ^{27th} April 2021.


