In compliance of order No. DMC SPO-2020/4863 dated 23-04-2021 and keeping in view the prevailing conditions due to Covid-19 pandemic in the district and in exercise of powers conferred under section 30 of Disaster Management Act, 2005 and all other powers in this behalf enabling the undersigned to impose restrictions during COVID 19, it has been decided to curtail the the timing of closure of Karyana shops/departmental stores/ bakeries/ confectioners in the large interest of public health in the areas of Municipal Council, Charkhi Dadri, Sub Division, Charkhi Dadri and Badhra district Charkhi Dadri.


1. All Mega marts/Malls ,Karyana shops/departmental stores/bakeries/confectioners/provision stores in the markets shall be allowed to operate up to 6:00 PM only.

This order shall come into force with immediate effect.

The Additional Deputy Commissioner- cum- District Municipal Commissioner, Charkhi Dadri, Superintendent of Police, Charkhi Dadri, all SDM's-incident commanders, all DSPs/ SHO's, EO/Secretary, MC, Charkhi Dadri, concerned BDPOs and any officer/official authorised by the undersigned or these officers shall strictly enforce these directions and take appropriate action against the persons(s) if found violating these directions as per section 51 to 60 of Disaster Management Act, 2005. The volunteers of the District Red Cross Society will assist the administration in spreading this message and helping authorities.

The District Information and Public Relations Officer, Charkhi Dadri shall give a wide publicity and disseminate this information through all modes of communication at nook and corner of the district.
