**ORDER**

In continuation of the office Order No 520/Camp/FRA dated 02.05.2021 and keeping in view the prevailing conditions due to Covid-19 pandemic in the district and in exercise of powers conferred under section 30 of Disaster Management Act, 2005 and all other powers enabling the undersigned to impose restrictions during COVID 19, it has been decided to regulate the timing of closure of shops as an amendment of the earlier order, in the large interest of public health in the areas of Municipal Council, Charkhi Dadri, Sub Division, Charkhi Dadri and Badhra district Charkhi Dadri is as under-

1. All the Restaurants//Eateries/Cafes and other such service providers shall remain open from 09:00 AM to 02:00 PM and from 06:00 PM to 08:00 PM only. There shall not be any dine-in facility extended within the vicinity of such service providers. However, take away/home delivery service is allowed .

2. Shops exclusively selling dairy and related products i.e. paneer, cheese, dahi, ghee etc. shall remain open from 05:00 AM to 11:00 AM and from 06:00 PM to 08:00 PM .These shops shall be closed between 11 AM to 6 PM ( Kiryana shops selling milk and dairying products shall not be considered as milk booth or dairies for the above purpose).

3. All Fruits and vegetables shop, including vendors, hawkers, grocery shops, egg /meat/poultry shops bakeries, confectioneries/kiryana shops and agriculture item and repair, animal feed and halwai shops shall operate only up to 02:00 PM.

4. The chemist shops, laboratories, emergency OPDs of registered medical establishments and petrol pumps shall remain open round the clock.

5. Repair shops like mechanic/hardware/ mobile etc. owned by self-serving individuals shall be open till 2.00 PM.

6. Road side dhabas to open till 10 PM.

7. National directives for COVID-19 management and general preventive measures such as use of face mask, frequent hand washing, and social distancing shall be followed religiously in all public places

All the SDM's /Duty Magistrates/Incident Commanders and Secretary, Market Committee, Charkhi Dadri are hereby directed to ensure that social distancing and personal hygiene norms in all areas and especially in the Vegetable Markets are followed strictly. Each and every person wears the masks compulsorily and there is no over-crowding in the mandies or elsewhere.

All concerned stakeholders/general public shall hereby ensure strict compliance of the above directions and also follow the guidelines as issued by the Ministry of Home Affairs/Ministry of Health & Family Welfare/Government of India as well as Government of Haryana from time to time.


This order shall come into force with immediate effect.

Therefore, I **Rajesh Jogpal, IAS, District Magistrate, Charkhi Dadri** in exercise of the powers vested in me by virtue of Section 26 along with section 30 of the Disaster Management Act, 2005, hereby direct that any person contravening this order shall be punishable under section 188 of the IPC along with the provisions of the Disaster Management Act, 2005.

ADC-cum-District Municipal Commissioner, Charkhi Dadri/, Superintendent of Police, Charkhi Dadri, all SDM's-incident commanders, all duty magistrates, all SHO's, EO/Secretary, MC, Charkhi Dadri, concerned BDPOs shall strictly enforce these directions and take appropriate action against the persons (s) if found violating these directions.

The District Information and Public Relations Officer, Charkhi Dadri shall give a wide publicity and disseminate this information through all mode of communication at nook and corner of the district.
