

ORDER

Whereas, Civil Surgeon, Charkhi Dadri vide his memo No. CSD/COVID-19/2021/647 dated 09.05.2021, has reported that maximum number of active COVID-19 cases, have been found in following areas/ colonies of District Charkhi Dadri:-

Sr. No.	Area/ Colony/town/ village
1	Ghasola
2	Dhani Phogat
3.	Sanwar

Now, therefore, on the basis of concentration of active COVID-19 cases and keeping in view of the containment, control and prevention of spread of COVID-19 in and surrounding area of the aforesaid colonies/ areas of District Charkhi Dadri and in pursuance of "The Haryana Epidemic Diseases, COVID-19, Regulation 2020 under the Epidemic Diseases Act, 1897, the aforesaid colonies/ areas of District Charkhi Dadri are hereby notified as "Macro Containment Zone" and following containment measures are hereby notified in macro containment zones with immediate effect till further orders:-

1. Sealing of geographic area of above colonies/ areas of District Charkhi Dadri.

Movement of the inhabitants of the containment zone shall be absolutely restricted and the entire affected pocket shall be sealed by deployment of adequate Police Force and setting up of required number of Checkpoints/Nakas etc. Necessary barricading of the containment zone shall be done by Police in consultation with MC and CMO and XEN, PWD, Charkhi Dadri. There shall be only one single entry/exit for these condoned zones. There shall be a total ban on the visitors in the containment zone. Only duly authorized essential items/service providers, wearing necessary protection gears e.g. masks, hairnet, gloves, PPEs etc. and carrying their authorized passes and valid ID cards will be allowed for entry in the containment zone. Superintendent of Police, Charkhi Dadri shall deploy round the clock adequate police force to effectively enforce the containment measures. To support the measures all necessary actions shall be duly taken by, CMO, XEN, PWD and Secy. MC, Dadri. All residents should be confined to their residences compulsorily. There shall be a restriction on all forms of social/ religious / family or any other gathering and all earlier permission if given stand revoked.

2. Barring entry & exit of population from the above macro containment zones.

3. Banning all kinds of vehicular movement and intermingling of people inside in the above areas.

(Action by :- SP & Duty Magistrate)

4. Initiating active surveillance of all households around the house of confirmed COVID-19 infected cases and passive surveillance of rest of the households.

(Action by :- CMO)

Sufficient number of Teams for conducting door to door screening of each and every person of the entire households falling the zone shall be deployed by the Chief Medical Officer, Charkhi Dadri. All of them would work under the strict directions of Chief Medical Officer. All the staff on duty shall be provided with Personal Protective Equipment (PPE) and other required devices/protection gears for screening / thermal scanning etc. Sufficient stocks of Personal Protective Equipment/devices required and medicines shall be kept in a mobile clinic to be set up near the entry/exit point of zone. Chief Medical Officer, Charkhi Dadri shall also deploy ambulances for carrying the health teams constituted for door to door screening/thermal scanning from Hospital to the zone and dropping them back.

Chief Medical Officer and DIPRO, Charkhi Dadri will depute staff to make awareness about do's and don't of COVID-19.

5. Hospital/ Home isolation of all suspected cases. CMO to take action in such cases.

6. The whole of the zone will be sanitized properly. Also the solid waste will be collected from all the houses and public places of the zone and disposed off as per the laid down norms of Health Department. Drivers must carry a valid driving license and be medically fit. It shall be ensured by BDPO the staff deployed for complete sanitization of the locality is adequately provided with Personal Protective Equipments (PPE), face masks, gloves, caps/hair nets, sanitizers, shoes and also follow social distancing norms, Gates/door knobs of each and every household will be properly sanitized by the visiting Sanitization team as per the protocols.

7. Demand of essential goods/ commodities such as raw ration/mild/grocery/ medicines/ vegetables/ gas cylinder/ animal fodder shall be distributed by the BDPO and DFSC, Charkhi Dadri. Distribution of dry ration by allowing selected vendors who shall supply as per eligibility shall be ensured by DFSC, Charkhi Dadri. The delivery of the same would be ensured at the door steps in the zone. All the essential items will be provided by fully sanitized trolleys/vehicles. Each trolley/vehicle shall be sanitized before entering and exiting from the zone.

(Action by DFSC, & BDPO)

8. Regular power supply in the zone shall be ensured by Xen, DHBVN, Charkhi Dadri.

9. The barricading shall be done by PWD in consultation with Police Officials and CMO, Charkhi Dadri. The barricading should result in effective cordoning of the area for effective sealing. For the same, necessary action to be taken by Xen, PWD, Charkhi Dadri and BDPO, Dadri/Baund/Jhojhu. Police authorities should satisfy themselves about the barricading and get it done as per their requirement. In addition to barricading tents (including fans, table, chairs etc) be erected for Incident Commander, Police & Health staff and other public servants on duty as per requirement.

(Action by Xen, DHBVN & Xen, PWD, Ch. Dadri)

10. Regular safe drinking water supply shall be ensured by Xen, Public Health Engineering, Ch. Dadri.

(Action by Xen, PHED, Ch. Dadri)

11. Prominent Citizens of the area will be encouraged to work as "Authorized Covid Volunteers" to aid the police and administration in enforcement of all the guidelines and motivating the citizens to comply with the same. They can register themselves with the Incident Commanders.



12. The Sub Divisional Magistrates of their respective areas shall be overall In-Charge of the zone and to oversee all the arrangements. All the officers/officials on duty shall perform /discharge their duties efficiently and any laxity on the part of any officer/official will attract strict action under the provisions of Disaster Management Act, 2005 and under Section 188 of the Indian Penal Code (45 of 1860).

Dr. Maha Singh, VS, AH&D, Ch. Dadri, Sh. Jitender Singh, TA, O/o Sub Divisional Agriculture office, Ch. Dadri and Dr. Jai Bhagwan, VS, AH&D, Achina will be Duty Magistrate-cum-Incident Commander in village Ghasola, Dhani Phogat and Sanwar respectively. They would be responsible for enforcement of all macro containment zone measures including law & order situation as per guidelines/SOPs issued in this regard by GOI, Govt. of Haryana, NEC from time to time in respective areas.




