

OFFICE OF DISTRICT MAGISTRATE, CHARKHI DADRI

ORDER

In continuation of my earlier order dated 22.10.2021 by which through the power vested in me under Section 144 of CrPC 1973, I had prohibited the manufacture, sale and use of all kinds of fire crackers during Diwali within the limits of District Charkhi Dadri.

Now the State Disaster Management Authority Haryana, Chandigarh vide memo No. DMC-SPO-2020/11885 Chandigarh, dated 31.10.2021 has passed the following orders/directions:-

“Amidst the COVID-19 pandemic through which the State of Haryana is passing and considering the approaching winter season during which the elderly children, person with comorbidities and others, may develop respiratory problems. During the approaching festival season of Diwali, Gurupurab and Kartik Purnima, Christmas eve, New Year eve, people usually bursts crackers which can adversely affect the respiratory health of vulnerable groups, besides, aggravating health condition of COVID-19 positive persons staying in home isolation. Accordingly, in compliance of the various directions of NGT and Hon'ble Supreme Court, while exercising the powers conferred under Section 24 of the Disaster Management Act 2005, the undersigned in my capacity as Chairperson, State Executive Committee hereby orders the following guidelines for strict implementation in the State:

1. There will be total ban against sale and use of all kinds of fire crackers in all the 14 NCR districts namely Bhiwani, Charkhi Dadri, Faridabad, Gurugram, Jhajjar, Jind, Karnal, Mahendragarh, Nuh, Palwal, Panipat, Rewari, Rohtak and Sonipat.

Therefore, in compliance of above mentioned letter and order/direction issued by the State Disaster Management Authority, Haryana, Chandigarh, there will be complete ban on sale and use of all kinds of fire crackers within the limits of District Charkhi Dadri for the approaching festival season of Diwali, Gurupurab and Kartik Purnima, Christmas eve, New Year eve. This order shall come into force with immediate effect.

Any violation or any person contravening this order shall be punishable u/s 51 to 60 of Disaster Management Act 2005 as well as under Section 188 of the Indian Penal Code, 1860 and other relevant provisions of different laws and regulations as applicable.


The Superintendent of Police, Charkhi Dadri, District Municipal Commissioner Bhiwani/Charkhi Dadri, All Sub Divisional Magistrates, DETC (ST), Bhiwani/Charkhi Dadri, All Tehsildars/Naib Tehsildars, BDPOs, DSPs, EO/Secy. Municipal Councils/Committees, SHOs of all police stations, Fire Officer, Charkhi Dadri and other fire office staff shall enforce this order in letter and spirit. All the above mentioned officers are, hereby, directed to conduct the raids, along with SHO concerned, to enforce this order.
