**ORDER**

Charkhi Dadri, the 3<sup>rd</sup> January, 2022

Whereas the State Disaster Management Authority, Haryana, Chandigarh has issued revised SOPs for social/academic/sports/entertainment/cultural/religious/political functions and other congregation received from Chief Secretary-cum-Chairperson Haryana State Executive Committee vide No. DMC-SPO-2020/14198 dated 01-01-2022 do hereby prohibit the following in territorial jurisdiction of District Charkhi Dadri in the interest of maintenance of public health, hygiene and safety in view of the COVID-19 pandemic.

2. Whereas, in exercise of the powers under section 6(2)I of the Disaster Management Act, 2005 National Disaster Management Authority (NDMA) has further directed the National Executive Committee to issue guidelines for containment of COVID-19 in the country.


3. Now, therefore, the following joint inspection teams for enforcing the above instructions/directions to ensure extensive checking and action against the violators as per law/rules/instructions/directions issued from time to time by the State Government of Haryana.

4. Additional Deputy Commissioner, Charkhi Dadri will be overall in charge for strict enforcement of the above measures in the district of Charkhi Dadri.
5. Sub Divisional Magistrate, Charkhi Dadri/Badhra will be Nodal Officer for strict enforcement of the above measures in their respective jurisdiction.
6. It is further directed that the Superintendent of Police, Charkhi Dadri, District Revenue Officer, Charkhi Dadri and District Development and Panchayat Officer, Charkhi Dadri shall ensure strict compliance of this order.
7. All Head Of Offices in the district shall have challaning power and shall collect their challan book from Civil Surgeon, Charkhi Dadri. All HOOs have to carry out extensive checking to ensure action against the violators as per law/rules/instructions/directions issued from time to time and strict compliance of orders/instruction/direction in their office premises.
8. Development Assistant O/o Deputy Commissioner, Charkhi Dadri shall be incharge to regulate Entry in Mini Secretariat. Superintendent of Police shall provide at least 6 home guards to Development Assistant in the said work. Superintendent of Police shall also provide at least 6 home gaurds in Civil Hospital, Charkhi Dadri for control Law and Order situation, and will aid CMO in maintaing COVID-19 appropriate behavior and protocols in civil hospital.
9. A COVID-19 control room shall be established in the district. District Revenue Officer, Charkhi Dadri shall be Nodal Officer for COVID-19 control room. District Education Officer, Charkhi Dadri shall depute adequate staff in COVID-19 control room for 24x7.
10. Tehsildar Charkhi Dadri/Badhra shall ensure adequate publicity through munadis in Villages.
11. DIO, NIC, Charkhi Dadri is directed to host this order on the official website <https://charkhidadri.gov.in> of district Charkhi Dadri.

Strict compliance of the above direction be ensured by all the concerned.

Any person violating this order will invite immediate penal action under Section 51 to 60 of Disaster Management Act, 2005 besides legal action under Section 188 of the IPC, as per National Directives and the offences and penalties for violating measures, as enclosed with the MHA order No. DMC-SPO-2020/14198 dated 01.01.2022 .


