ORDER UNDER SECTION 144 Cr. P.C

Whereas, pursuant to the containment measures of the Government of Meghalaya, Home (Political) Department issued vide No. POL.75/2020/Pt-1/99, dated 18th May, 2021 and in supersession to this office order No.NGH/CON/COVID-19/17/Pt.5/2021/146, Dated 21st May 2021 and in view of surging of Covid-19 cases in the state of Meghalaya, there is urgent need to take stringent steps in entire North Garo Hills District.

And whereas, the prevailing situation in the district is also alarming, there is need to put in place preventive measures to contain the increasing cases of Covid-19 by way of observance of strict protocols and advisories issued by Government of Meghalaya, Health & Family Welfare Department and Home (Political) Department.

Now, therefore, I Shri R.P. Marak, IAS, District Magistrate, North Garo Hills District, Resubelpara in exercise of the powers vested upon me under Section 144 Cr. P.C read together with Section 3 of the Epidemic Diseases Act and Covid-19 Regulations do hereby impose following restrictions in the entire North Garo Hills District:-

- 1. TOTAL CURFEW will be extended from 6:00 P.M of 28th May, 2021 till 6:00 A.M of 31st May, 2021.
- 2. Inter-District or Intra-District movement of persons is not permitted. No person is to step out without valid reasons.
- 3. All Inter-State Border roads whether PWD road, PMGSY, MGNREGS, village road, public road etc. will be sealed.
- 4. Inter-District movement of all types of vehicles within the state and within the district will be restricted.

Exemptions only will be given to the following services:

- 1. Vehicles carrying essential commodities like FCI vehicles, gas cylinder carrying vehicles, oil tanker etc.
- 2. Ambulances and medical emergency services.
- 3. Petrol pumps/L.P.G. distributors.
- 4. Wholesale & Retail Pharmacies.
- 5. Fire & Emergency Services.
- 6. Food & Civil Supply Department.
- 7. Public Work Department (PWD).
- 8. Public Health Engineering (PHE) Department.
- 9. A.H. & Veterinary Department.
- 10. Security forces, Police on duty, Medical Staff on duty, Executive Magistrate on duty, Municipal vehicle and staff on duty, Pharmacies and other public utility emergency services.
- 11. MePDCL and Telecom staff on duty.

- 12. All Banks.
- 13. Passing to other districts through National Highway via Berubari Entry Point and Dainadubi Entry Point will be regulated from case to case basis by Executive Magistrate and Police Officers on duty.
- 14. Coming out for Covid vaccination will be exempted. However, no one will be allowed to unnecessary come out in the pretext of going for Covid vaccination and strict action will be taken against them.

This order will be effective from 06:00 P.M. of 28th May, 2021 till 06:00 A.M. of 31st May, 2021.

The urgency of the matter did not otherwise permit to issue prior notice to the public.
