A part from the expenses incurred or authorized by the candidate/election agent directly, all expenditure incurred or authorized by the political party, other associations, bodies of persons, individuals in connection with the election of the candidate are also required to be included in the account. The only exception is the expenses incurred on travel of specified leaders of the political party on account of their travel for propagating the programme of the party. (See Explanation 1 and 2 of Section 77(1) of the Representation of the People Act, 1951).
6. In the Annexure 14 (Part-A), if the expenditure on any item shown in columns 2 and 3 is incurred/authorized by any political party/association/body of persons/any individual (other than the candidate or his election agent), its/his name and complete address must be shown in columns 7 and 8.
7. In the Annexure 14 (Part-A), the total expenditure referred in columns 2 and 3 should include all expenditure in cash and the value of all goods and services received in kind by the candidate or his election agent from any source.
