



ORDER

In pursuance to directions issued by the Chief Secretary to Government Haryana (Political & Parliamentary Affairs Department) vide letter No. 41/14/2016-5 Pol dated 2<sup>nd</sup> April, 2020, to contain the spread of Novel Coronavirus, as it is high time to avoid community spread of Covid-19, it is hereby ordered to take following preventive measures:-

- i. All Inter-State and Intra-State borders be sealed. Particular emphasis should be given to the areas of high density population, hot beds;
- ii. The highly populated slum areas are most vulnerable hotspots for community spread of the disease. Therefore, these need to be properly sanitized and other protocol should be followed. These areas should be monitored closely and every effort should be made to identify corona positive cases and should be further treated as per protocol.
- iii. All viable community places in the slum areas should be properly cleaned and frequent sanitization should be carried regularly.
- iv. Maintenance of personal hygiene and physical distancing should be ensured.
- v. Proper thermal scanning should be done.
- vi. In all slum areas, proper arrangements should be made for quarantining the suspected cases as per protocol.


All concerned are hereby directed to ensure effective enforcement of this order. DIPRO should ensure wide publicity through all modes.


**Subject: Preventive measures to be taken to contain the spread of Noval Coronavirus.**


The Hon'ble Chief Minister while reviewing the preventive measures taken by the State to contain the spread of Noval Coronavirus with the Hon'ble Members of Parliament from Haryana on 02.04.2020 through Video Conference, has directed that it is high time to avoid community spread of Noval Coronavirus (COVID-19). During the meeting, following directions were given :

- i. All Inter-State and Intra-State border be sealed, particular emphasis be given to the areas of high density population, hot beds;
- ii. In Gurugram, Faridabad, Panipat and Panchkula there are highly populated slum areas where proper sanitization and other protocol be followed strictly;
- iii. These highly populated slum areas are most vulnerable hotspots for community spread of the disease. Therefore, these need to be monitored closely and every effort be made to identify corona positive cases and be further treated as per protocol ;
- iv. All viable community places in the slum areas by properly cleaned and frequent sanitization work be carried regularly;
- v. Maintenance of personal hygiene and physical/social distancing be ensured.
- vi. Proper thermal scanning be done;
- vii. In all slum areas, proper arrangements be made for quarantization of the suspected cases as per protocol.
