

ORDER
(WEARING OF FACE COVER IN COMPULSORY IN ALL PUBLIC PLACES, WORK PLACES)

Whereas the Haryana State Disaster Management Authority has issued Orders bearing No.DMC-PO-I-2020/2501 dated 16th April, 2020 whereby it has been directed that in larger public interest COVID-19 being contagious in nature, wearing of face mask by any person who is moving in any public place is essential. While exercising powers conferred under Section 22 of the Disaster Management Act, 2005, it has been directed that the following measures should be followed to prevent the spread of COVID-19 pandemic :

1. All residents of State of Haryana, venturing out of their houses for any authorized purpose must wear a cloth or three ply face mask at all time. The method of wearing mask should be such that both nose and mouth are covered and lower edge of the mask should come below chin.
2. This shall apply equally to pedestrians, cyclists and any vehicle whether two or more wheelers.
3. It is mandatory for wearing of masks for persons working any site/office/workplace including mandis and procurement centres.
4. No person/officer/officials will attend any meeting/gathering/work place without wearing these masks.
5. It shall be the responsibility of the employer to ensure that all their employees wear either a 3-ply mask or a cloth mask without fail.
6. These masks may be standard masks or homemade washable cloth masks that can be reused after proper washing and disinfecting them.
7. The disposal of masks should be ensured in a proper manner.

It has been made ample clear by the S.D.M.A. that violation of these instructions will be punishable under Section 188 of the Indian Penal Code (48 of 1860) and police authorities are empowered to immediately arrest the violators. The compliance of this order is mandatory.

Hence in pursuance of the said directions and in exercise of powers conferred under Section 30 of the Disaster Management Act, 2005, all concerned are hereby ordered that the aforementioned directions should be implemented meticulously in the entire territory of district Sirsa without fail.
