**Subject: Implementation of Consolidated revised guidelines for containment of COVID-19 issue by the Ministry of Home Affairs, Government of India.**

In continuation of letter no. PS/FCR&ACS/2020/Spl-5 dated 19.04.2020 issued by Revenue & Disaster Management Department, Haryana, the following additional instruction is issued with reference to small construction sites:

*"No permission will be required for small residential / industrial construction sites employing upto 10 workers only within the limit of municipal corporation, municipalities and rural areas where workers are available on site and no workers are required to be brought in from outside (i.e. in-situ), subjected to the compliance of Standard Operating Procedure w.r.t. social distancing, sanitization etc. as stipulated in Annexure-II of Ministry of Home Affairs, Government of India order no.40-3/2020-DM-I(A), dated 15.04.2020.*

*The District Magistrates will ensure necessary compliance in this regard alongwith monitoring, supervision of SOPs by such individuals through Incident Commander of area having jurisdiction, in their districts."*



In continuation of Ministry of Home Affairs order No. 40-3/2020-DM-I(A) dated 15<sup>th</sup> April, 2020, dated 16<sup>th</sup> April, 2020, dated 19<sup>th</sup> April, 2020, 21<sup>st</sup> April, 2020, 24<sup>th</sup> April, 2020 & clarifications issued vide press release dated 25.04.2020 and State Government order No. DMC-SPO-2020/5177 dated 15<sup>th</sup> April, 2020, DMC-SPO-2020/5186 dated 17<sup>th</sup> April, 2020, DMC-SPO-2020/5206 dated 19<sup>th</sup> April, 2020, DMC-SPO-2020/5207 dated 19<sup>th</sup> April, 2020 & DMC-SPO-2020/5207 dated 22<sup>nd</sup> April, 2020 and in exercise of the powers conferred under section 22 of the Disaster Management Act, 2005, the undersigned, in her capacity as Chairperson, Haryana State Executive Committee hereby orders the following amendments in the consolidated revised guidelines for strict implementation by all concerned within the State of Haryana:

**Modifications**

- I. In Sub-clause 1(x), the term 'shopping complexes' is replaced with 'market complexes within the limit of municipal corporations and municipalities':

**Inclusions**

- I. Sub-clause (xiii) & (xiv) under Clause 14 on Commercial and private establishments:
  - xiii. All shops registered under the the Shops and Establishment Act of the respective State/UT, including shops in residential complexes and market complexes, except shops in multi-brand and single brand malls, outside the limits of municipal corporations and municipalities, with 50% strength of workers with wearing of masks and social distancing being mandatory.
  - xiv. All shops, including neighborhood shops and standalone shops, shops in residential complexes, with the limits of municipal corporations and municipalities, registered under the the Shops and Establishment Act of the respective State/ UT, except shops in market complexes and multi-brand and single brand malls, with 50% strength of workers with wearing of masks and social distancing being mandatory.

Ministry of Home Affairs, Govt. of India vide Press Release dated 25.04.2020 has clarified that the above order implies that:


- a. In rural areas, all shops, except those in shopping malls are allowed to open.



- b. In **urban areas**, all standalone shops, neighbourhood shops & shops in residential complexes are allowed to open. Shops in markets/ market complexes and shopping malls are not allowed to open.

It is also clarified that sale by **E-commerce** companies will continue to be permitted for essential goods only.

It is further clarified that sale of **liquor** and other items continues to be prohibited as specified in the National Directives for COVID-19 management.

**Note :** As specified in the consolidated revised guidelines, these shops will not be permitted to open in areas, whether rural or urban, which are declared as containment zones by respective States/ UTs.

# Clarification on MHA order allowing Opening of Shops

Ministry of Home Affairs issued an Order yesterday on amendments in the consolidated revised guidelines on lockdown measures to allow opening of shops. (<https://pib.gov.in/PressReleaseIframePage.aspx?PRID=1618049>)

This Order implies that:

- In rural areas, all shops, except those in shopping malls are allowed to open.
- In urban areas, all standalone shops, neighborhood shops & shops in residential complexes are allowed to open. Shops in markets/market complexes and shopping malls are *not* allowed to open.

It is clarified that sale by e-commerce companies will continue to be permitted for essential goods only.

It is further clarified that sale of liquor and other items continues to be prohibited as specified in the National Directives for COVID-19 management.

*As specified in the consolidated revised guidelines, these shops will NOT BE PERMITTED TO OPEN in areas, whether rural or urban, which are declared as CONTAINMENT ZONES by respective States/ UTs.*


In continuation of Ministry of Home Affairs's Order No. 40-3/2020-DM-I(A) Dated 15th April, 2020 and in exercise of the powers, conferred under Section 10(2)(l) of the Disaster Management Act, the undersigned, in his capacity as Chairperson, National Executive Committee, hereby orders the following amendments in the consolidated revised guidelines for strict implementation by Ministries/Departments of Government of India, State/Union Territory Governments and State/Union Territory Authorities:

**Modifications**

- i. In Sub-clause 1 (x), the term 'shopping complexes' is replaced with 'market complexes within the limits of municipal corporations and municipalities'.

**Inclusions**

- i. Sub-clause (xiii) & (xiv) under Clause 14 on Commercial and private establishments:
  - xiii. All shops registered under the the Shops and Establishment Act of the respective State/UT, including shops in residential complexes and market complexes, except shops in multi-brand and single brand malls, **outside the limits of municipal corporations and municipalities** with 50% strength of workers with wearing of masks and social distancing being mandatory.
  - xiv. All shops, including neighborhood shops and standalone shops, shops in residential complexes, **within the limits of municipal corporations and municipalities**, registered under the the Shops and Establishment Act of the respective State/UT, except shops in market complexes and multi-brand and single brand malls, with 50% strength of workers with wearing of masks and social distancing being mandatory.
