Memo.

May kindly refer to Govt. of India, MHA's order dated 29.04.2020 followed by Haryana Govt. SOP issued vide endst. No. SPL/101/Covid/2020 dated 03.05.2020 and this office WAN message No.26462-571/Misc. Desk/SB-CID, dated 05.05.2020.

2. Tentative schedule of train to facilitate the transportation of **agricultural labourers only** back to their native places, stranded due to N-Covid-19 pandemic from **Rohtak to Katihar (Bihar) is on 08.05.2020**. In this train, agricultural labourers of Bihar stranded in various parts of Haryana (Districts YNR, KKR, KNL, SPT, PWL, SRS, RTK & GGM) belonging to following districts of Bihar:

Katihar, Araria, Kishanganj, Purnia, Madhepura, Sahrasa & Supol


are proposed to be transported. You are further requested to ensure:-

1. The District Nodal Officers (Civil) with the assistance of GM, Roadways of their respective districts shall ensure the smooth movement of such agricultural labourers from different locations of their districts to District Rohtak.

2. The data base of all the agricultural labourers to be transported shall be properly maintained by each district in the enclosed proforma and its soft copy must be sent to DC & SP/Rohtak by tonight positively.
3. DC & SP concerned shall ensure proper thermal screening of all the passengers (Agricultural labour) while sending them to Rohtak by tomorrow morning.
4. The district authorities shall also ensure that the appropriate arrangements for their food, water and other basic essential needs are made.
5. It shall also be ensured that the labourers destined for a particular district of a State are to be seated in the same coach/bogy.
6. A DSP rank officer shall be nominated as the Nodal Officer from the police side in each district for necessary coordination regarding movement of agricultural labor from every district to the district of departure i.e. Rohtak from where the train is scheduled to depart on 08.05.2020.
7. **FOR SP/GRP ONLY (.)** She shall coordinate with and provide all necessary assistance to the district officials for smooth boarding of such labourers from the designated railway station i.e. Rohtak while maintaining social distancing norms and following COVID-19 protocol. She shall also depute a DSP rank officer for better coordination with DC/SP Rohtak.
8. DC & SP/Rohtak shall be personally responsible to coordinate with all the districts from where agricultural labourers are to be transported to Rohtak, their stay in the shelter homes, proper data base, their boarding into the train and enforcement of social distancing norms.
9. Sh. Rajesh Kalia, SP/Intelligence, CID Haryana (96460-33222) and DSP/CID Rohtak (98135-16389) shall coordinate all these arrangements at Rohtak.
