

DISTRICT DISASTER MANAGEMENT AUTHORITY, SIRSA.

ORDER



Whereas, the National Disaster Management Authority (NDMA), is satisfied that the country is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization, and after considering this fact has taken certain effective measures to prevent its spread across the country while ensuring maintenance of essential services and supplies, including health infrastructure. Further guidelines under the Disaster Management Act, 2005 has also been issued by the Home Secretary, Ministry of Home Affairs, Government of India from time to time. A nation-wide lock down is also being enforced w.e.f. 4th May, 2020 for a period of two week.

Whereas, it has been made aware by the Superintendent of Prison, District Prison, Sirsa vide his office letter No.2782 dated 11.05.2020 that a High Powered Committee was held on 24.03.2020 under the Chairmanship of Hon'ble Mr.Justice Rajiv Sharma, Judge, Punjab and Haryana High Court, Chandigarh whereby it was directed to identify places in and around the prison which can be used as a temporary prison in case if there is an outbreak of the virus. It has further been informed by the Superintendent of Prison, District Prison, Sirsa that the building of Mata Harkhi Devi Girls Hostel, Chaudhary Devi Lal University, Sirsa has been found to be suitable for establishing Temporary Jail, if necessity so arises to shift the inmates to contain the spread of Corona virus.

Hence, in exercise of the powers conferred under Section 34 of the Disaster Management Act, 2005 and all other powers under the Act ibid, enabling the undersigned in this behalf, the entire building of Mata Harkhi Devi Girls' Hostel, Chaudhary Devi Lal University, Sirsa is hereby requisitioned and declared as a Temporary Jail for shifting of housing the inmates of District Jail to contain the spread of Corona virus so that social distancing and person hygiene norms are followed effectively, with immediate effect till further orders.

In order to implement these orders Sub Divisional Magistrate, Sirsa, is hereby appointed as Incident Commander. All other line department officials in the specified area will work under the directions of Incident Commander. The Registrar, Chaudhary Devi Lal University, Sirsa is directed to hand over the possession of the said building to the Superintendent of Prison, District Jail, Sirsa in the presence of the Incident Commander/SDM, Sirsa to enable him to set up the Temporary Jail as per the norms. The Superintendent of Prison, District Prison, Sirsa shall ensure that the building so requisitioned is fully got sanitized and other basic amenities/facilities such as masks, hand-sanitizers and other services as required under the Jail Manual are made available in coordination with the CDLU authorities, as the case may be.

Any contravention of these directions by any person will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005 beside legal action under Section 188 of the I.P.C.
