

**ORDER**

Consequent upon detection of a COVID-19 positive case in Gali No.5, Gali Moman Numberdar Wali, Bhadra Bazar, Sirsa, as prescribed in the protocol of nCOVID-19 and to prevent its spread in the adjoining areas, the areas/houses as specified in the orders was declared as Containment Zone and the area falling in Street No.4 and Street No.6 was declared as Buffer Zone, by this office vide order bearing No.33334-74/MA dated 21.05.2020.

It has been reported by the Civil Surgeon, Sirsa vide his office letter No.IDSP/2020/1773 dated 16.06.2020 that as per guidelines of containment strategy, the operations can be scaled-down, if no secondary laboratory confirmed COVID-19 case is reported from the containments and buffer zones for at-least four weeks after the last confirmed case has been isolated and all his contacts have been followed-up for 28 days.

It has further been reported that the mandatory period of 28 days is over/elapsed and no secondary laboratory confirmed COVID-19 has been reported during this period. It has been suggested to scale-down the ongoing containment operations in Gali No.5, Gali Moman Lambderdar Wali, Bhadra Bazar, Sirsa C-Block, Sirsa w.e.f. 18<sup>th</sup> June, 2020. However, a passive medical out-post consisting of a Medical Officer, Pharmacist and ANM etc. will be posted in the locality by the Civil Surgeon, Sirsa

Hence, in view of the observations and suggestions made above, it is hereby ordered to scale-down the on-going containment operations as enforced by this office orders as referred above, with effect from 18<sup>th</sup> June, 2020 with the directions to Civil Surgeon, Sirsa to establish a temporary medical out-post comprising of a Medical Officer, Pharmacist and ANM etc. at a suitable location in this area to carry out passive reporting of I.L.I. (Influenza Like Illness) and SARI cases, for a further period of 14 days.
