

ORDER

Consequent upon detection of COVID-19 positive cases in **Village Dhingtania (Block Sirsa), and Village Gosaiana, (Block N.Chopta) district Sirsa**, as prescribed in the protocol of nCOVID-19 and to prevent its spread in the adjoining areas, **Containment Zones and Buffer Zone were declared** by this office vide order bearing No.34493-540/MA dated 07.06.2020 and 34741-790/MA dated 07.06.2020 respectively.

It has been reported by the Civil Surgeon, Sirsa vide his office letter No.IDSP/2020/1975 dated 03.07.2020 that as per guidelines of containment strategy, the operations can be scaled-down, if no secondary laboratory confirmed COVID-19 case is reported from the containments and buffer zones for at-least four weeks after the last confirmed case has been isolated and all his contacts have been followed-up for 28 days.

It has further been reported that the mandatory period of 28 days is over/elapsing and no secondary laboratory confirmed COVID-19 has been reported during this period in the abovesaid Containment Zones. It has been suggested to **scale-down the abovesaid Containment Zones**. However, a passive medical out-post consisting of a Medical Officer, Pharmacist and ANM etc. will be posted in the locality by the Civil Surgeon, Sirsa

Hence, in view of the observations and suggestions made above, it is hereby ordered to scale-down the on-going containment operations in the following Containment zones, as enforced by this office orders as referred above, with effect from 06.07.2020 with the directions to Civil Surgeon, Sirsa to establish a temporary medical out-post comprising of a Medical Officer, Pharmacist and ANM etc. at a suitable location in this area to carry out passive reporting of I.L.I. (Influenza Like Illness) and SARI cases, for a further period of 14 days :
