

ORDER

Consequent upon detection of five more Corona positive cases from VRDL, Department of Microbiology, Maharaja Agrasen Medical College, Agroha (Hisar) in the same vicinity of **Gali No.8, Aggarsain Colony, Ward No.14, Sirsa, therefore, the Containment Zone as declared and specified in the orders issued vide this office Endst.No.41821-850/MA dated 07.07.2020 is hereby further EXTENDED** for all the purposes and objective as prescribed in the protocol of nCOVID-19 District Containment Plan (Health Department) to prevent its spread in the adjoining areas, as under :

"From House of Sh.Vinod S/o Sh.Tara Chand Soni to House of Sh.Rajiv S/o Sh.Bhag Chand (on one side) and from House of Sh.Ravi S/o Sh.Madan Lal Monga to Sh.Des Raj S/o Sh.Butta Ram."

However, to prevent/contain its further spread and to break cycle of transmission morbidity due to COVID-19 in the adjoining areas, **the same action plan** as provided under the protocol is prescribed to carry out active search for cases through physical house to house surveillance; testing of all suspect cases as per sampling guidelines; contact tracing; strict enforcement of social distancing; clinical management of all confirmed cases; quarantine; isolation and other public health measures in the Containment Zones and passive search in Buffer Zone **will be applied for this extended Containment Zone.**

Other health-care activities and duties as specified/prescribed in the aforementioned orders will continue to be carried out by all concerned, as such.
