

ORDER

Consequent upon detection of five more Corona positive cases from VRDL, Department of Microbiology, Maharaja Agrasen Medical College, Agroha (Hisar) in the same vicinity of Kirti Nagar, Ward No.9-10, Begu Road, Sirsa, District Sirsa, the Containment Zone as declared and specified in the orders issued vide this office Endst.No.41076-41110/MA dated 02.07.2020 subsequently extended vide Endst.No. 41596-41640/MA dated 06.07.2020; Endst.No.41790-820/MA dated 07.07.2020 and 42130-159/MA dated 08.07.2020 is hereby further **EXTENDED** for all the purposes and objective as prescribed in the protocol of nCOVID-19 District Containment Plan (Health Department) to prevent its spread in the adjoining areas, as under :

“DSP Mohan Lal Street – from Main Road Gulati Cloth House to House of Sh.Vijay Pal Dhandal (H.No.11/2306) and House of Sh.Nitin Sharma (H.No.11B/2257) and Shyam Gali : from House of Sh.Vinod Jhorar and Sh.Murari Singh upto the end of Shyam Gali.”

However, to prevent/contain its further spread and to break cycle of transmission morbidity due to COVID-19 in the adjoining areas, **the same action plan** as provided under the protocol is prescribed to carry out active search for cases through physical house to house surveillance; testing of all suspect cases as per sampling guidelines; contact tracing; strict enforcement of social distancing; clinical management of all confirmed cases; quarantine; isolation and other public health measures in the Containment Zones and passive search in Buffer Zone **will be applied for this extended Containment Zone.**

Other health-care activities and duties as specified/assigned in the aforementioned orders will also continue to be carried out/discharged, as such by all concerned officers.
