

ORDER

Consequent upon detection of COVID-19 positive cases in Gali Dr.GK Aggarwal, Ward No.14, Sirsa, as prescribed in the protocol of nCOVID-19 and to prevent its spread in the adjoining areas, the areas/houses falling under these localities, was declared as Containment Zone and surrounding area was declared as Buffer Zone, by this office vide order bearing No.38321-350/MA dated 25.06.2020 and further extended vide Endst.No.39966-996/MA dated 30.06.2020.

Now it has been reported by the Civil Surgeon, Sirsa vide his office letter No.IDSP/2020/2095 dated 11.07.2020 that "Tirupati Hospital, Sirsa" is located within the Containment zone and no health care services are being provided by this hospital. It has been suggested by the Civil Surgeon, Sirsa to designate Tirupati Hospital as Treating Hospital for this Containment zone by reducing the area of containment zone by starting the Containment from residence of Dr.G.K. Aggarwal, in public interest.

Hence, in view of the suggestion made by the Civil Surgeon, Sirsa as stated above, "Tirupati Hospital, Dr.G.K. Aggarwal Street, Ward No.14, Sirsa" is hereby designated as a Treating Hospital for this Containment Zone and the Containment Area is accordingly reduced by starting the containment from residence of Dr.G.K.Aggarwal. The Management of the Hospital shall strictly follow all preventing measures such as wearing of face covers/masks; social distancing norms and public hygiene etc. in the Hospital also.
