

ORDER

Consequent upon detection of a COVID-19 positive case in Gali Dr.G.K. Aggarwal Wall, Ward No.14, Sirsa, as prescribed in the protocol of nCOVID-19 and to prevent its spread in the adjoining areas, the areas/houses falling under the locality, was declared as Containment Zones and surrounding area was declared as Buffer Zone, by this office vide order bearing No.38321-350/MA dated 25.06.2020.

Subsequently, one more case was reported in the same locality, therefore, the existing Containment Zone was extended by this office vide office orders bearing No.39966-96/MA dated 30.06.2020

It has been reported by the Civil Surgeon, Sirsa vide his office letter No.IDSP/2020/2364 dated 24.07.2020 that as per guidelines of containment strategy, the operations can be scaled-down, if no secondary laboratory confirmed COVID-19 case is reported from the containments and buffer zones for at-least four weeks after the last confirmed case has been isolated and all his contacts have been followed-up for 28 days.

It has further been reported that the mandatory period of 28 days is over/elapsed and no secondary laboratory confirmed COVID-19 has been reported during this period in the Containment Zones formed originally. It has been suggested to scale-down the ongoing containment operations in these Containment Zone w.e.f. 25.07.2020. However, a passive medical out-post consisting of a Medical Officer, Pharmacist and ANM etc. will be posted in the locality by the Civil Surgeon, Sirsa

Hence, in view of the observations and suggestions made above, it is hereby ordered to scale-down the ongoing containment operations in the following Containment Zone as enforced by this office orders as referred above, with effect from 25.07.2020 with the directions to Civil Surgeon, Sirsa to establish a temporary medical out-post comprising of a Medical Officer, Pharmacist and ANM etc. at a suitable location in this area to carry out passive reporting of I.L.I. (Influenza Like Illness) and SARI cases, for a further period of 14 days:

a) Containment Zone: Gali Dr.GK Agarwal (Original Zone) : w.e.f. 25.07.2020

However, the Containment Zone extended subsequently shall continue to be active upto 30.07.2020 and shall be scaled down on 30.07.2020 accordingly.
