

## ORDER

Consequent upon detection of a COVID-19 positive cases at different localities in district Sirsa, as prescribed in the protocol of nCOVID-19 and to prevent its spread in the adjoining areas, the following areas/localities were declared as **Containment Zone** and **as Buffer Zone** by this office vide orders as mentioned against each :

It has been reported by the Civil Surgeon, Sirsa vide his office letter No.IDSP/2020/2323 dated 24.07.2020 that as per guidelines of containment strategy, the operations can be scaled-down, if no secondary laboratory confirmed COVID-19 case is reported from the containments and buffer zones for at-least four weeks after the last confirmed case has been isolated and all his contacts have been followed-up for 28 days.

It has further been reported that the mandatory period of 28 days is over/elapsed and no secondary laboratory confirmed COVID-19 has been reported during this period. It has been suggested to **scale-down the ongoing containment operations in the above noted containment zones w.e.f. 31.07.2020**. However, a passive medical out-post consisting of a Medical Officer, Pharmacist and ANM etc. will be posted in the locality by the Civil Surgeon, Sirsa

Hence, in view of the observations and suggestions made above, it is hereby ordered to **scale-down** the on-going containment operations as enforced by this office orders as referred above in the above noted Containment Zones **with effect from 31.07.2020** with the directions to Civil Surgeon, Sirsa to establish a temporary medical out-post comprising of a Medical Officer, Pharmacist and ANM etc. at a suitable location in this area to carry out passive reporting of I.L.I. (Influenza Like Illness) and SARI cases, for a further period of 14 days.
