

DISTRICT DISASTER MANAGEMENT AUTHORITY, SIRSAORDER

Whereas the Haryana State Executive Committee, State Disaster Management Authority vide order bearing No.DMC-SPO-2020/10046 dated 21st August, 2020 has directed that in order to contain further spread of Coronavirus(nCov) in Haryana, all public and private offices except those dealing with essential services and all shopping malls and shops in the market area, except those dealing with essential goods and services shall remain closed on Saturday and Sunday through the territory of Haryana. All other National Directives and SOPs issued by N.D.M.A. for COVID-19 management that are currently in force shall continue to be strictly followed. These orders shall remain in force till further orders.

Hence, in pursuance to the said directions, it is hereby ordered that the same should be enforced in the territorial jurisdiction of district Sirsa by

Hence in pursuance to the orders of Haryana State Disaster Management Authority issued by the Chief Secretary-cum-Chairperson, Haryana State Executive Committee as referred above, it is hereby ordered that strict compliance of the aforementioned directions must be ensured by all concerned/stakeholders meticulously.

The Superintendent of Police, Sirsa as well as Sub Divisional Magistrate, Sirsa, Dabwali, Ellenabad and Kalanwali shall be responsible for strict enforcement/implementation of these directions in their respective jurisdictions.

Any person violating these lockdown measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005.

District Information and Public Relations Officer, Sirsa shall promulgate and disseminate the guidelines/orders widely through all modes of communications.
