ORDER

Since some more Corona positive cases have been reported by VRDL, Department of Microbiology, MAMC, Agroha (Hisar) in the same vicinity of Gandhi Clinic Wali Gali, Gobind Nagar, Hisar Road, Sirsa (District Sirsa), therefore, the Containment Zone as declared and specified in the orders issued vide this office Endst. No. 87461-87490/MA dated 02.10.2020 from House No. 13/676 (Sh. Dushyant Devgun) to house No. 674 (Sh. Palvinder) (on one side) and from house of Sh. Chaman Lal Kamboj, Advocate to vacant plot (on another side) in Gandhi Clinic Wali Gali, Gobind Nagar, Hisar Road, Sirsa, is further extended for all the purposes and objective as prescribed in the protocol of nCOVID-19 District Containment Plan (Health Department) to prevent its spread in the adjoining areas.

However, to prevent/contain its further spread and to break cycle of transmission morbidity due to COVID-19 in the adjoining areas, the same action plan as provided under the protocol is prescribed to carry out active search for cases through physical house to house surveillance; testing of all suspect cases as per sampling guidelines; contact tracing; strict enforcement of social distancing; clinical management of all confirmed cases; quarantine; isolation and other public health measures in the Containment Zone and passive search in Buffer Zone will be applied for this extended Containment Zone. Other activities and duties as specified/prescribed in the aforementioned orders required to be discharged will also continue to be carried out as such by all concerned officers.
