

ORDER

Whereas considering the unprecedented surge in COVID-19 cases across the State, the Government of Haryana has considered it necessary to take effective measures to prevent its spread in the State of Haryana;

AND whereas, in exercise of powers conferred under section 22(2)(h) of the Disaster Management Act, 2005, the Chief Secretary to Govt. Haryana-cum-Chairperson, Haryana State Executive Committee has declared lockdown from 03.05.2021 (05.00 AM onwards) to 10.05.2021 (till 05.00 AM) in the State of Haryana vide order No. DMC-SPO-2020/5215 dated 02.05.2021 alongwith directions to all the Departments of the State Government and District Administration for strict implementation of guidelines during the period of lockdown in letter and spirit.

Now, some representatives of confectionery/bakery shops of Sirsa has submitted a representation that they are engaged in sale of bread, cake, pastries, patties etc. which is required by the general public on daily basis. If they are not allowed to operate their business/outlets during lockdown period, it will affect their business as well as inconvenience to citizens. So they have requested to operate their business during the said lockdown period.

Therefore, all the confectionery/bakery shops in district Sirsa are hereby allowed to run their business from 6.00 AM to 09.00 AM (morning) and from 5.00 PM to 07.00 PM (evening) during the lockdown period subject to the condition that Management/Owners, staff/workers and customers etc. should strictly follow COVID-19 appropriate behavior including simple public health measures, social distancing (2 gaz ki doori), wearing of face covers/masks, hand hygiene with soap and sanitizers at all times. However, the confectionery/bakery shops are directed to focus on home delivery. Executive Officer, Municipal Council, Sirsa & Food Security Officer, Sirsa are directed to frequently check that the time slot and COVID-19 appropriate behavior is strictly followed by the owners.
