

**ORDER**

Whereas, considering the unprecedented surge in COVID-19 cases across the State, the Government of Haryana has considered it necessary to take effective measures to prevent its spread in the State of Haryana;

AND whereas, in exercise of powers conferred under section 22(2)(h) of the Disaster Management Act, 2005, the Chief Secretary to Govt. Haryana-cum-Chairperson, Haryana State Executive Committee has declared lockdown from 03.05.2021 (05.00 AM onwards) to 10.05.2021 (till 05.00 AM) in the State of Haryana vide order No. DMC-SPO-2020/5215 dated 02.05.2021.

In compliance with the aforementioned guidelines/directions, the directions are necessary to strictly prohibit the movement of individuals, except for essential activities in the district during the lockdown period.


Therefore, the following officers/officials are hereby deployed with S.H.O.s, as mentioned against each, to ensure that COVID appropriate behaviour i.e. mandatorily wearing face masks, social distancing, hand hygiene etc. is strictly adhered to by all in public places and congregation/gathering/unnecessary crowd is avoided at all cost to contain the spread of COVID-19 Epidemic as well as to maintain law and order during the above mentioned lock down period. It is further directed that all residents of district Sirsa shall stay indoor during the above mentioned lockdown period. No person shall unnecessarily leave their homes or shall move on foot or by vehicle or travel or stand or roam around on any road or public places during the period of lockdown for which the team should frequently inspect the areas under their jurisdictions.
