All other contents of above referred order dated 03.05.2021 shall remain the same. However, essential commodity providers shall strictly follow the above daily schedule by following COVID-19 appropriate behavior e.g. wearing face masks, social distancing (three feet/one meter) etc..



If anyone is found contravening these instructions, legal action shall be taken against concerned as per relevant Acts/Rules.

It is reiterated that all essential commodity providers should encourage & facilitate home delivery to minimize the movement of individuals outside their homes.

DIPRO shall extend wide publicity through all mode of communication for the information of public at large.

All concerned Officers are hereby directed to ensure strict enforcement of these instructions/guidelines in letter and spirit.
