

ORDER

Whereas considering the unprecedented surge in COVID-19 cases across the State, the Government of Haryana has considered it necessary to take effective measures to prevent its spread in the State of Haryana and declared lockdown till 10.05.2021 (05.00 AM) in the State of Haryana vide order No. DMC-SPO-2020/5215 dated 02.05.2021;

AND whereas, the District Administration, Sirsa has issued schedule for opening of shops/establishments dealing with essential commodities/services, so as to avoid inconvenience to citizens. Accordingly, whole-sale fruit & vegetable market at Rania Road, Sirsa is operating its business through various shops/outlets from the above mentioned 'sabzi mandi'. It has been brought to the notice of this office that there is over-crowding at the time of operation of this mandi (5.00 AM – 10.00AM) and the businessmen, staff, workers, vendors, customers, visitors are not following Covid appropriate behavior i.e. simple public health measures, social distancing (2 gaz ki doori), wearing of face covers/masks, hand hygiene with soap and sanitizers etc. which can lead to community transmission of this deadly virus.

Now, I am satisfied that the directions are necessary to all concerned/stakeholders that every person at public or work places should follow Covid appropriate behavior i.e. simple public health measures, social distancing (2 gaz ki doori), wearing of face covers/masks, hand hygiene with soap and sanitizers etc. to contain the spread of COVID-19 Epidemic.

Therefore, a committee under the chairmanship of Sh. Rajesh Kumar, HCS, Chief Executive Officer, Zila Parishad/DRDA, Sirsa (98106-34277) consisting of the following members, is hereby constituted:-

1. Sh. Charan Singh, DMEO, Sirsa (93555-87118)
2. Sh. Vikas Setia, Secretary, Market Committee, Sirsa (94161-39934)

This committee will be responsible to visit the mandi every day (5.00 AM - 10.00 AM) and ensure that Covid appropriate behavior i.e. simple public health measures, social distancing (2 gaz ki doori), wearing of face covers/masks, hand hygiene with soap and sanitizers etc. is being observed by all the businessmen, staff, workers, vendors, customers, visitors during business hours. In order to contain spread of COVID-19 no congregation/gathering must be allowed.

This order shall come into force with immediate effect till further directions/instructions.

Any person violating these directions/instructions will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

Superintendent of Police, Sirsa is directed to provide sufficient police contingent in sabzi mandi every day at the time of opening i.e. 5.00 AM till 10.00 AM.

DIPRO shall extend wide publicity through all mode of communication for the information of public at large.
